

Attention is specifically drawn to the fact that in terms of section 50(2) of the Act an objection must be in relation to a specific individual property and not against the valuation roll as such. The completed objection forms must be returned <u>by hand</u> to the Municipal Office where the account is held. Kindly bring along your Section 49 notice when submitting your objection, as this will expedite the submission process. A copy of your Section 49 notice can also be obtained at the Municipal Offices.

<u>No</u> form of electronic submission will be accepted. THE CLOSING DATE FOR OBJECTIONS IS EXTENDED TO 15:30 ON 25 July 2014. <u>No</u> late objections will be accepted.
