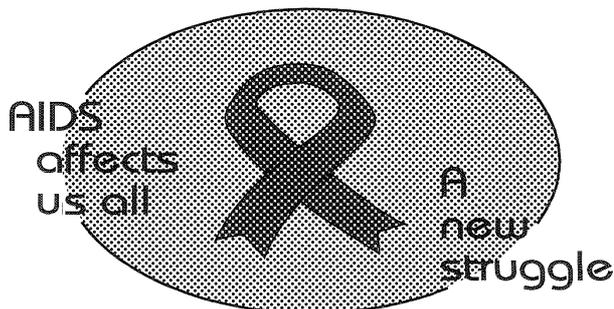

#### GAUTENG GAMBLING ACT, 1995

#### APPLICATION FOR CONSENT TO HOLD AN INTEREST CONTEMPLATED IN SECTION 38 OF THE ACT
