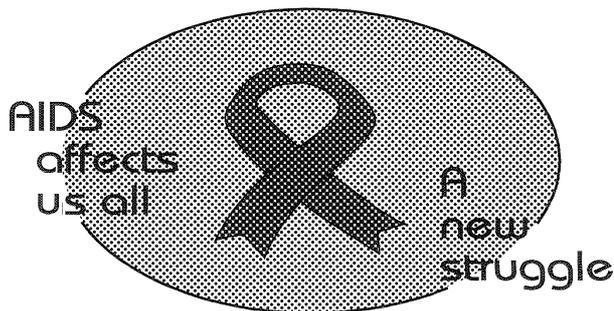


PROCLAMATION

No. 1, 2015**THE PREMIER
GAUTENG PROVINCE****CONSTITUTION OF THE REPUBLIC OF SOUTH AFRICA, 1996****TRANSFER OF ADMINISTRATION AND POWERS AND FUNCTIONS ENTRUSTED BY
LEGISLATION TO CERTAIN MEMBERS OF THE EXECUTIVE COUNCIL**

In terms of section 137 of the Constitution of the Republic of South Africa, 1996, I hereby from 1 April 2015 transfer the administration and the powers or functions entrusted by legislation to the specified Member of the Executive Council as set out in the Schedule.

Any reference to a Member of the Executive Council, excluding a reference to the Member of the Executive Council for Finance in so far as it relates to fiscal matters, in any legislation regarding a power or function transferred must be interpreted as a reference to the respective Member to whom the functions is transferred.

Given under my Hand at Johannesburg this ⁰³ day of March, Two Thousand and Fifteen.
