



APPLICATION FOR A TOTALIZATOR AGENT LICENCE

Notice is hereby given that Phumelela Gaming & Leisure Ltd at 14 Turf Club Street intends submitting an application to the Gauteng Gambling Board to appoint Cherise Anne Mansour as its agent at Shop 17, Main Road, Rivonia.
