**LOCAL AUTHORITY NOTICE 817 OF 2017****DRAFT SPECIAL RATINGS AREA BY-LAW  
CITY OF JOHANNESBURG METROPOLITAN MUNICIPALITY**

Notice is hereby given in terms of section 7(1) of the Rationalization of Local Government Affairs Act, 10 of 1998, that the City, at its Ordinary Council meeting on 23 June 2016, declared its intention to make a new Special Rating Area By-law and Special Rating Area Policy

In terms of the provisions of section 22 of the Local Government : Municipal Property Rates Act 6 of 2004, a Municipality may by resolution of its council determine an area within that municipality a special ratings area and levy an additional rate on property in that area for the purpose of raising funds for improving or upgrading that area.

In this regard the City has adopted a draft Special Rating Area By-law, and draft Special Rating Area Policy on which public comment is being sought.

Copies of the draft By-law and accompanying draft policy will lie open for inspection during normal office hours for 30 days from date of publication of this notice at the Metropolitan Centre at the Group Legal & Contracts Department's Reception at 158 Civic Boulevard, Braamfontein, 3<sup>rd</sup> Floor, A-Block.
