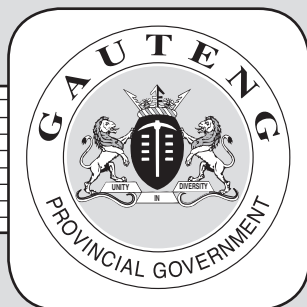

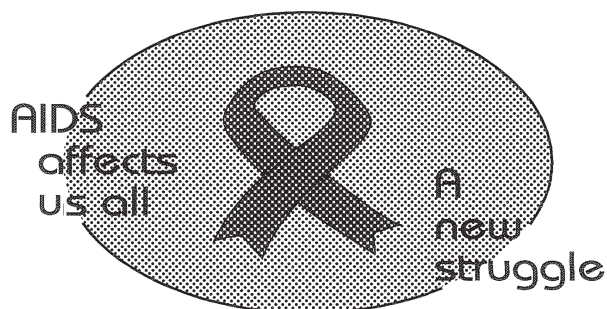

It is hereby notified in terms of the provisions of Section 6(8) of the Gauteng Removal of Restrictions Act, 1996 (Act No 3 of 1996), that the City of Tshwane has approved the application for the removal and amendment of certain conditions contained in Title Deed T08130/16, with reference to the following property: The Remainder of Erf 299, Menlo Park.

The following condition(s) and/or phrases are hereby cancelled: Conditions (a), (c), (d), (e), (f), (g), (h), (i), (k), (l), (m), (n), (o).

This removal will come into effect on the date of publication of this notice.

that the City of Tshwane has approved the application for the amendment of the Tshwane Town-planning Scheme, 2008, being the rezoning of the Remainder of Erf 299, Menlo Park, to Residential 3, Dwelling Untis, with a density of 93 dwelling units per hectare of gross erf area, subject to certain further conditions.

Map 3 and the scheme clauses of this amendment scheme are filed with the Head of Department: Department of Economic Development, Gauteng Provincial Government and the Executive Director: City Planning and Development, City of Tshwane, and are open to inspection during normal office hours.
