APPLICATION FOR AN AMMENDMENT OF A ROUTE OPERATOR LICENSE TO RELOCATE

Notice is hereby given that Crazyslots (Pty)Ltd intends submitting an application to the Gauteng Gambling Board for an amendment of a route operator license to relocate its premises from Unit E, 2 Dale Lace Avenue, Randparkridge, Randburg to Wild Fig Business Park, Block A Suite 14, 1494 Cranberry Street, Honeydew, 2170;

Attention is directed to the provisions of Section 20 of the Gauteng Gambling Act, 1995 which makes provision for the lodging of written representations in respect of the application.

Written representations should be lodged with the Chief Executive Officer, Gauteng Gambling Board, Private Bag 15, Bramley, 2018, within one month from **13 December 2017**.

Any person submitting representations should state in such representation whether or not they wish to make oral representations at the hearing of the application.

Such representations shall contain at least the following information:

- (a) The name of the applicant to which representations relate;
- (b) The ground or grounds on which representations are made;
- (c) The name, address, telephone and fax number of the person submitting the representations
- (d) Whether the person submitting the representations request the board to determine that such person's identity may not be divulged and grounds for such request; and
- (e) Whether or not they wish to make oral representations at the hearing of the application.
