

#### **LOCAL AUTHORITY NOTICE 307 OF 2018**

# CITY OF JOHANNESBURG METROPOLITAN MUNICIPALITY DECLARATION OF LOCAL STATE OF DISASTER DISASTER MANAGEMENT ACT, 2002 (ACT NO. 57 OF 2002)

The City Council of the Johannesburg Metropolitan Municipality having considered the effects of the severe weather conditions including a tornado that occurred in parts of the jurisdictional area of the City of Johannesburg Metropolitan Municipality namely: Alexandra, Braamfischerville, Doornkop, Emdeni, Fleurhof, Lawley, Lenasia, Lufhereng, Meadowlands, Protea Glen, Protea Glenridge, Rugby Club informal settlement, Slovo Park, Snake Park, Thubelisha, Tshepisong and Westbury and concluding that existing legislation and contingency arrangements do not adequately provide for the City of Johannesburg Metropolitan Municipality to effectively deal with the disaster, and also considering the special circumstances caused by the severe weather conditions, by way of a Council Resolution taken on 31 January 2018, resolved to Declare a Local State of Disaster in terms of Section 55(1) of the Disaster Management Act No. 57 of 2002.

The Council further authorise, in terms of Section 55(2) of the Disaster Management Act No. 57 of 2002, the City Manager to issue the required administrative directions in respect of the declared Local State of Disaster, as and when necessary, as contemplated in Section 55(2) of the said Act, subject to Section 55(3) thereof.

The duration of the Local State of Disaster in terms of this declaration -

- lapses three months after it has been declared;
- b. may be terminated by the council by notice in the provincial gazette before it lapses in terms of paragraph (a); and
- c. may be extended by council by notice in the provincial gazette for one month at a time before it lapses in terms of paragraph (a) or the existing extension is due to expire.
