# ACCEPTANCE AND IMPLEMENTATION OF THE AMENDED PRELIMINARY DESIGN OF PROVINCIAL ROAD P126-1(K72) BETWEEN ROADS P16-1(K76) AND P39-1(K13) FOR A NEW ACCESS ROAD. DISTRICT: KRUGERSDORP

In terms of section 8(6) and (7) of the Gauteng Transport Infrastructure Act, 2001 (Act No 8 of 2001) ("the Act") it is hereby notified for general information that the Member of the Executive Council for the Gauteng Province ("the MEC") for Roads and Transport has considered and accepted the amended Preliminary Design of provincial road P126-1(K72) between P16-1(K76) and P39-1(K13) for implementation.
