Request for public comments for amendment of the problem properties By-Law of the City of Johannesburg

Notice is hereby given in terms of section 7(1) of the Rationalisation of Local Government Affairs Act, 10 of 1998, that the City, at its Ordinary Council Meeting on 21 & 22 June 2018 declared its intention to make amendments to the Problem Properties By Law.

The Problem Properties By Law was promulgated in 2014. Since the promulgation of the enforcement thereof, the Group Forensic and Investigation Services Department identified further provisions of the By Law that needed to be amended.

According to Group Forensic and Investigation Services Department, these proposed amendments are necessary to provide for:

1. The identification, control and management of the dilapidated, abandoned and problem properties in the City of Johannesburg,
2. Ensuring the safety and wellbeing of the community of the City,
3. Bringing the By Law into line with current practices and national standards,
