DETERMINATION OF SALARIES AND ALLOWANCES PAYABLE TO MEMBERS OF THE EXECUTIVE COUNCIL AND THE DIFFERENT MEMBERS OF THE PROVINCIAL LEGISLATURE WITH EFFECT FROM 1 APRIL 2019

- I, Malemolla David Makhura, Premier of the Premier, under section 6(3)(a) of the Remuneration of Public Office Bearers Act, 1998 (Act No. 20 of 1998) ("the Act"), read with President's Notice No. 114 of 2020, published in Government Gazette No. 43043 dated 21 February 2020, hereby determine that the salaries and allowances payable to the positions of office bearers in Column 3 are, with effect from 1 April 2019, set out in Column 4 of the Schedule, subject to the provisions of section 6(2) to (8) of the Act and the following terms and conditions.
- The total remuneration packages referred to in paragraph 1 above include the following elements:
- 2.1 A basic salary component equal to 60% of the total package, which is pensionable;
- 2.2 An amount of R120 000 per annum, which is an amount to which section 8(1)(d) of the Income Tax Act, 1962 (Act No. 58 of 1962), applies. This amount is included in the basic salary component;
- 2.3 An employer's pension benefit contribution equal to 22.5% of pensionable salary;
- 2.4 A flexible portion for the remaining amount of the total remuneration.
- 2.5 Premier's Notice No. 1 of 2019, published in Provincial *Gazette*, Extraordinary, No. 21 of 25 January 2019, is hereby repealed.
