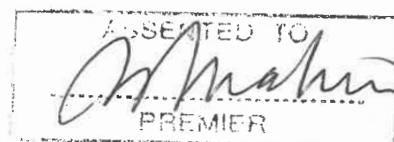

ACT

To provide for the authorisation of an unauthorised expenditure from the Provincial Revenue Refund.

BE IT ENACTED by the Provincial Legislature of the Province of Gauteng, as follows:—

Authorisation of an unauthorised expenditure from the Provincial Revenue Fund

1. (1) Expenditure to the amount of R5 920 000.00 incurred by the Gauteng Provincial Government during the period April 2018 to March 2019, in relation to Life Esidimeni claims which were paid in line with an arbitration award issued on 19 June 2018 which was recommended by The Standing Committee on Public Accounts authorisation by the Provincial Legislature, is hereby authorised. 5

(2) The expenditure mentioned in the subsection (1) is set out in Schedule 1.

(3) The Provincial Revenue Fund is, in terms of section 34(1) of the Public Finance Management Act, 1999 (Act No. 1 of 1999), charged with the expenditure mentioned in subsection (1). 10

Short title

2. This Act is called the Gauteng Provincial Unauthorised Expenditure Act, 2021.
