## NOTICE REQUEST FOR PUBLIC COMMENT FOR THE AMENDMENT OF THE JOBURG MARKET BY-LAWS

### Cllr Tefo Raphadu

In terms of Section 7 (5) of the rationalization of Local Government Affairs Act No 10 of 1998 the Council of the City of Johannesburg, Metropolitan Municipality declares its intention of the implementation of a proposed new by-law for the Jo'burg Market.

Jo'burg Market ("JM") is a Municipal Entity being administered in terms of section 156 (1) and (2) of the Constitution read with Parts B of Schedules 4 and 5 thereto. The market facilities are located approximately 5 kilometers south of the Johannesburg Central Business District in City Deep. The purpose of the bylaw is to regulate the trading of fresh produce and associated activities at the Market and the by-law is consequently in its application limited to the JM site. The Public is hereby invited to submit written comments on the draft amendments to the Jo'burg Market by-law.

The purport of the amendment is to:

- Introduce additional definitions in the by-laws.
- Delete certain provisions/phrases in the by-laws.
- Make additions to certain expressions in the by-laws.
- Include provisions relating to:
  - Licensing of Market Agents
  - Alignment with legislation
  - Consignment control measures
