It is hereby notified in terms of the provisions of Sections 48 (2) and 50 (5) of the City of Ekurhuleni Metropolitan Municipality Spatial Planning and Land Use Management Act By-law of 2019, that the City of Ekurhuleni Metropolitan Municipality has approved the simultaneous Removal of Restrictive Title Conditions 2.(b), 2.(f), 2.(g), 2.(i), 2.(i)(i), 2.(i)(ii) and 2. (j) from Deed of Transfer T. 602/2021 in respect of Portion 1 of Erf 24 Lakefield Township and the Removal of Restrictive Title Conditions 1.(b), 1.(f), 1.(g), 1.(i), 1.(i)(i), 1.(i)(ii) and 1.(j) from Deed of Transfer T. 42805/2020 in respect of Erf 25 Lakefield Township and the simultaneous Amendment of the Ekurhuleni Town Planning Scheme of 2014 by the Rezoning of Portion 1 of Erf 24 Lakefield Township from "Residential 1" and Erf 25 Lakefield Township from "Business 3" respectively to "Business 2" for Shops (Excluding Liquor Stores), Offices, Medical Consulting Rooms, Beauty Salons, Restaurants (Excluding Pubs, Roadhouse and Gambling/Slot Machines) and including Car Wash, subject to conditions and the Consolidation of the aforementioned erven.

The Ekurhuleni Amendment Scheme, **B0736** and the adopted scheme clauses and adopted annexure of this amendment scheme are filed with the Municipality, and are open to inspection during normal office hours.
