I, Jacob Mamabolo, a member of the Executive Council responsible for Public Transport and Roads Infrastructure in Gauteng, in terms of Subsection 3 (1) of the National Road Traffic Act, 1996 (Act No. 93 of 1996) do hereby appoint the:

- i. RTMC as a Registering Authority for the purposes of operating and managing Grade F Driving License Testing Centre's (DLTCs) in Eco Park DLTC, 349 Witchazel Avenue, Highveld Extension, Centurion; Waterfall Park DLTC, 253 Howick Close, Midrand and Kempton Park areas, or any other area which the Department may identify for the establishment of a new Grade F DLTCs. The areas of the City of Tshwane, City of Johannesburg, City of Ekurhuleni Metros; and Sedibeng, Mogale City, Randwest City and Merafong Municipalities are to be areas of jurisdiction of the RTMC registering authority for the purposes of managing and operating Grade F DLTCs.
- ii. GMA as a Registering Authority for the purpose of applying for the registration of Grade F DLTCs only in the Gautrain Stations.
