I, Malemolla David Makhura, Premier of the Province of Gauteng, hereby, in terms of section 137 of the Constitution of the Republic of South Africa, 1996, transfer with effect from 1 April 2022 the administration of and powers and functions entrusted by—

- (a) Chapter 5 of the Children's Act, 2005 (Act No. 38 of 2005) ("the Children's Act"), only in respect of partial care facilities that provide early childhood development services as defined in section 91(2) and early childhood development programmes as defined in section 91(3) of the Children's Act to the extent that they provide such programme or service;
- (b) Chapter 6 of the Children's Act; and
- (c) Chapters 20 and 21 of the Children's Act, only in respect of the powers and functions transferred in paragraphs (a) and (b),

in so far as they relate to the MEC for Social Development, from such MEC to the MEC for Education.

Any reference to the MEC for Social Development in so far as it relates to the powers and functions in Chapters 5, 6, 20 and 21 of the Children's Act must be construed as a reference to the MEC for Education.
