**Definition**

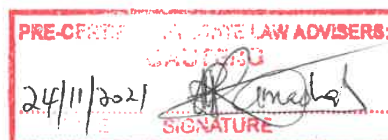
1. In these Regulations, unless the context otherwise indicates—  
"the Regulations" means the Gauteng Gambling Regulations, 1997, and "the Act" means the Gauteng Gambling Act, 1995 (Act No. 4 of 1995).

**Substitution of regulation 82 of Regulations**
