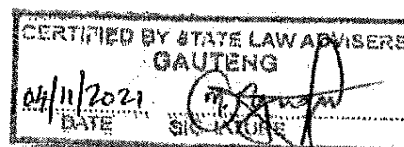
Members of the public, interested persons or communities are hereby invited to submit written representation on, or objections to, the proposed determination and publication, within 30 days of the publication of this notice.
