PROVINCIAL NOTICE 85 OF 2022

INVITE FOR NOMINATIONS OF CANDIDATES TO SERVE AS LOCAL COMMITTEE MEMBERS OF THE GAUTENG LIQUOR BOARD

1. I, Mpho Franklin Parks Tau, Member of the Executive Council for Economic Development, Agriculture and Environment in the Province of Gauteng, hereby in terms of section 20 of the Gauteng Liquor Act, 2003 (Act No. 2 of 2003), invite interested persons to submit written nominations of candidates for appointment to serve as members of the Local Committees of the Gauteng Liquor Board. A person may nominate himself or herself.
2. Each Local Committee consists of no less than five and not more than seven members per metropolitan or district council who are appointed as follows:
- (a) one or more persons admitted as an attorney or advocate with at least five years' experience in the legal profession or administration of justice;
 - (b) a representative of the municipality, being a senior employee with experience in or in charge of town or city planning or a similar function;
 - (c) a representative of the municipality, being a senior employee with experience in or in charge of local economic development or a similar function; and
 - (d) one or more representatives appointed from the community in the area of the local committee appointed by reason of his or her knowledge in the field of welfare or socio-economic development or social services.
3. No person shall be appointed a member of the Local Committee if such person
- (a) is not a citizen of the Republic and resident in the Province;
 - (b) is an un-rehabilitated insolvent;
 - (c) is subject to an order of court declaring such person to be mentally ill or disordered;
 - (d) has at any time been convicted, whether in the Republic or elsewhere of theft, fraud, forgery or uttering, perjury, an offence under the Gauteng Liquor Act, 2003 or the Prevention and Combating of Corrupt Activities Act, 2004 (Act No. 12 of 2004) or any offence involving dishonesty;
 - (e) has at any time been removed from an office of trust on account of misconduct; or
 - (f) has a direct or indirect financial interest in a liquor business or is a spouse of such a person.
4. The nomination must include the following information:
- (a) the full names of the nominee;
 - (b) motivation for the nominee;
 - (c) a certified copy of the nominee's identity document;
 - (d) certified copies of the nominee's qualification(s);
 - (e) comprehensive CV of the nominee; and
 - (f) a letter of consent from the nominee to serve as a member of the Local Committee.
5. Written nominations may be submitted by email at glbadvert@gauteng.gov.za on or before Monday, 14 February 2022. Nominations received after the said closing date will not be considered.
