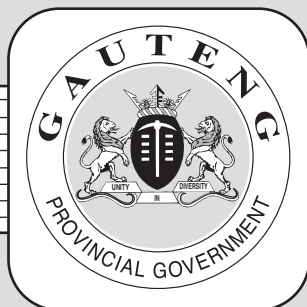

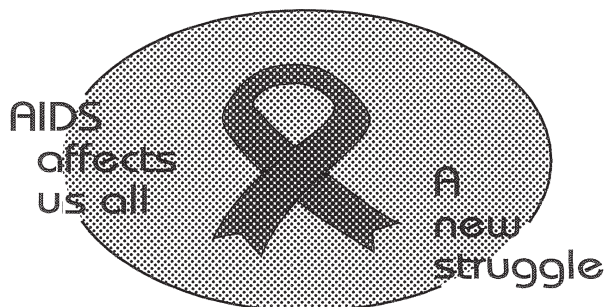

(ACT NO. 1 OF 1999)NOTICE RELATING TO NOMINATIONS OF MEMBERS OF GGT2030
TECHNICAL ADVISORY COMMITTEE PANEL

1. The Member of the Executive Council for Economic Development, Agriculture and Environment hereby invites interested persons to submit written nominations for appointment of candidates to serve as members of the Technical Advisory Committee Panel established in accordance with regulation 20 of the Treasury Regulations issued in terms of section 76 of the Public Finance Management Act, 1999 (Act No. 1 of 1999), to provide project management support towards Growing Gauteng Together 2030 (GGT2030) on implementation, monitoring and evaluation of the high-growth sectors and economic infrastructure programmes across all Gauteng corridors.

2. Candidates must have full understanding of the GGT2030 and transversal skills, such as investor intelligence, investor mobilisation and investment design, and partnership structuring between public and private sector entities, including risk allocation, design thinking, rapid iteration and agile approaches with respect to programme design, monitoring and implementation, efficient and time-optimised co-ordination and reporting. In addition, members must have content expertise on project management, automotive, energy, digital and ICT services sector.

3. A person shall be appointed by virtue of his or her knowledge and active involvement in—(a) one or more of the 10 high-growth sectors of the GGT2030 (b) economic infrastructure development, e.g. Special Economic Zones (SEZ) and Industrial Parks or Hubs (c) Township Economy Revitalisation and Small Micro and Medium Enterprise (SMME) Development (d) Programme and Project Management, Local Production and Local Content Frameworks and (e) business

development support programmes, including both financial and non-financial support.

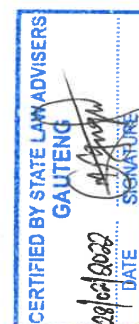
4. Written nominations, including self-nomination, must be submitted online or by email ONLY to TACadvent@gauteng.gov.za on or before 13 March 2022 and must include—(a) full names of the nominee (a) motivation for the nominee (c) comprehensive CV of the nominee (d) certified copy of the nominee's identity document not older than six months (e) certified copies of the nominee's qualification(s) not older than six months (f) letter of consent from the nominee to serve as member of the Panel. Failure to submit the above information may lead to a disqualification of a nominee and nominations receive after the closing date shall not be considered.

5. A person must not be nominated and shall not be appointed if that person—(a) is not a citizen of the Republic and is not resident in the Province (b) is a member of Parliament, a Provincial Legislature, a Municipal Council or a House of Traditional Leaders established in terms of the Constitution (c) is an unrehabilitated insolvent (d) is of unsound mind as declared by a competent court (e) has at any time been convicted of an offence involving dishonesty or been removed from an office of trust on account of misconduct or (f) has previously been removed from any other committee for breach of committee rules.

6. The Panel shall consist of no less than twelve (12) and no more than twenty (20) members who shall serve a term of office not exceeding a period of three (3) years.
