

GENERAL NOTICE 361 OF 2022 THE PREMIER

PUBLIC SERVICE ACT, 1994 (PROCLAMATION NO. R. 103 OF 1994)

GENERAL NOTICE

DETERMINATION REGARDING THE TRANSFER OF THE GAUTENG AIDS COUNCIL SECRETARIAT FROM THE GAUTENG DEPARTMENT OF HEALTH TO THE GAUTENG OFFICE OF THE PREMIER WITH EFFECT FROM 1 APRIL 2022

- I, Malemolla David Makhura, Premier of the Province of Gauteng, hereby in terms of section 3A(b) of the Public Service Act, 1994 (Proclamation No. R. 103 of 1994), make the Determination regarding the transfer of the Gauteng AIDS Council Secretariat from the Gauteng Department of Health to the Gauteng Office of the Premier with effect from 1 April 2022.
- 2. In accordance with regulation 32 of the Public Service Regulations, 2016, issued in terms of section of the Public Service Act, 1994 (Proclamation No. R. 103 of 1994),—
 - (a) the Gauteng Department of Health must transfer all concomitant resources, namely all those employees or posts, assets and tools of trade, pertaining to the Gauteng AIDS Council Secretariat, to the Gauteng Office of the Premier;
 - (b) the Gauteng Office of the Premier must coordinate the transfer and ensure that the terms and conditions of employment of the employees attached to the posts referred to in the attached Schedule are, upon transfer, on the whole, not less favourable than those on which such employees were employed by the Gauteng Department of Health;
 - (c) the Gauteng Office of the Premier must accept accountability for the Gauteng AIDS Council Secretariat from the date of transfer;
 - (d) the Head of Department: Gauteng Department of Health must retain accountability for matters originating prior to the date of transfer; and

- (e) the transfer of the funds must take place in accordance with the requirements of requirements of regulation 6.5 of the Treasury Regulations, 2005, issued in terms of section 76 of the Public Finance Management Act, 1999 (Act No. 1 of 1999).
- 3. The Head of Department: Gauteng Department of Health must, in accordance with section 42 of the Public Finance Management Act, 1999 (Act No. 1 of 1999), draw up an inventory of assets and liabilities and provide the Director-General: Gauteng Office of the Premier with substantiating records, including personnel records of employees that are being transferred. Both the Head of Department: Gauteng Department of Health and the Director-General: Gauteng Office of the Premier must sign the inventory when the transfer takes place. The Head of Department: Gauteng Department of Health must file a copy of the signed inventory with the Gauteng Provincial Treasury and the Auditor-General within 14 days of the transfer.
- 4. All affected employees are transferred in terms of section 14 of the Public Service Act, 1994 (Proclamation No. R. 103 of 1994), and continue employment in the public service without any break in service in accordance with section 14A of the Public Service Act, 1994 (Proclamation No. R. 103 of 1994).
- 5. This Determination must, in accordance with paragraph 6.5.2, accompany the request for the transfer of funds, if any, as per paragraph 6.5.1, of regulation 6.5 of the Treasury Regulations, 2005, issued in terms of section 76 of the Public Finance Management Act, 1999 (Act No. 1 of 1999).
