**GAUTENG GAMBLING ACT, 1995**  
**APPLICATION FOR A BOOKMAKER LICENCE**

Ervostar (Pty)Ltd t/a Max Bet lodged an application with the Gauteng Gambling Board for the right to operate a bookmaker licence at Shop 35 Kwa Thema Square, Erf 76 Maryvlei Ext 1, Ekurhuleni. In terms of regulation 13, 'an application may, with the approval of the Board, be amended in any respect at any time prior to final consideration thereof by the Board'.

Notice is hereby given to interested parties that we herewith intend lodging an application to amend our application for a bookmaker licence by removing the premises from Shop 35 Kwa Thema Square, Erf 76 Maryvlei Ext 1, Ekurhuleni and locating same at Shop 4, Tsakane Mall, Corner Mandela and Modjadji Streets, Portion 1 of Erf 7940, Tsakane. This application to amend our premises location will be open for public inspection at the offices of the Board from Tuesday 07 June 2022.

Attention is directed to the provisions of section 20 of the Gauteng Gambling Act, 1995 which makes provision for the lodging of written representations in respect of the application. Such representations shall contain at least the following information:

- a) the name of the applicant to which representations relate;
- b) the ground of grounds on which representations are made;
- c) the name, address, telephone and fax number of the person submitting the representations
- d) whether the person submitting the representations requests the Board to determine that such person's identity may not be divulged and the grounds for such request; and
- e) whether or not they wish to make oral representations at the hearing of the application.

Any representations not containing the information required above shall be of no force or effect and shall be deemed not to have been lodged with the Board.

Written representations should be lodged with the Chief executive Officer, Gauteng Gambling Board, Private Bag 15, Bramley, 2018, within one month from Tuesday 07 June 2022
