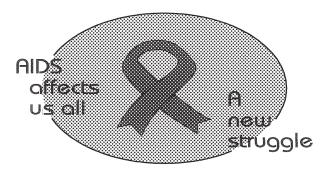

DECLARATION OF LOTUS GARDENS EXTENSION 32 AS APPROVED TOWNSHIP

In terms of Section 103 of the Town-planning and Townships Ordinance, 1986 (Ordinance No 15 of 1986), the City of Tshwane hereby declares the township of Lotus Gardens Extension 32 to be an approved township, subject to the conditions as set out in the Schedule hereto.

CONDITIONS UNDER WHICH THE APPLICATION MADE BY TERRE INVESTMENTS NO 8 (PTY) LTD (REGISTRATION NUMBER 1999/013342/07), UNDER THE PROVISIONS OF CHAPTER III: PART C OF THE TOWN-PLANNING AND TOWNSHIPS ORDINANCE, 1986 (ORDINANCE NO 15 OF 1986), FOR PERMISSION TO ESTABLISH A TOWNSHIP ON THE REMAINDER OF PORTION 523 (A PORTION OF PORTION 6) OF THE FARM PRETORIA TOWN AND TOWNLANDS 351JR, PROVINCE OF GAUTENG, HAS BEEN GRANTED

1 CONDITIONS OF ESTABLISHMENT

1.1 NAME

The name of the township shall be Lotus Gardens Extension 32.

1.2 DESIGN

The township shall consist of erven, parks and streets as indicated on General Plan SG No 2899/2019.

1.3 PROVISION AND INSTALLATION OF ENGINEERING SERVICES

The township owner shall, at its costs and to the satisfaction of the local authority, design, provide and construct all engineering services including the internal roads and the stormwater reticulation, within the boundaries of the township, to the satisfaction of the local authority. If external services are not available or the existing services are not sufficient to accommodate the township, special arrangements shall have to be made after consultation with the applicable departments to the satisfaction of the local authority.

1.4 CONDITIONS IMPOSED BY THE GAUTENG DEPARTMENT OF AGRICULTURE AND RURAL DEVELOPMENT (GDARD)

The township owner shall at his own costs comply with and strictly adhere to all the conditions and/or requirements imposed by the Department of Agriculture and Rural Development including those by which exemption has been granted from compliance with regulations No 1182 and 1183 promulgated in terms of section 21, 22 and 26 of the Environmental Conservation Act, (Act 73 of 1989) or the National Environmental Act, 1998 (Act 107 of 1998) as amended and the Regulations thereto, as the case may be for the development of this township.

1.5 ACCESS

- 1.5.1 Access to or egress from the township shall be provided to the satisfaction of the local authority and/or Tshwane Roads and Stormwater Department.
- 1.5.2 No access to or egress from the township shall be permitted along the lines of no access as indicated on the approved layout plan of the township CPD/LGSX32/7.

1.6 ACCEPTANCE AND DISPOSAL OF STORMWATER

The township owner shall arrange for the drainage of the township to fit in with that of the adjacent road Van den Berg Street and Mothadisi Street and all stormwater running off or being diverted from the road shall be received and disposed of, to the satisfaction of the local authority.

1.7 REFUSE REMOVAL

- 1.7.1 The township owner shall at his own expense have all litter within the township area removed to the satisfaction of the City of Tshwane, when required to do so by the City of Tshwane.
- 1.7.2 The township owner shall provide sufficient refuse collection points in the township and shall make arrangements to the satisfaction of the local authority for the removal of all refuse.

1.8 REMOVAL OR REPLACEMENT OF EXISTING SERVICES

If, by reason of establishment of the township, it should be necessary to remove or replace any existing municipal, TELKOM and/or ESKOM services, the cost of such removal or replacement shall be borne by the township owner. For purposes of removal or replacement the township owner shall, at its own costs, protect the services by means of the registration of servitudes in favour of the City of Tshwane, should it be deemed necessary.

1.9 DEMOLITION OF BUILDINGS AND STRUCTURES

The township owner shall at its own costs cause all existing buildings/structures situated within the building line reserves, side spaces, or over common boundaries to be demolished to the satisfaction of the local authority, when requested thereto by the local authority or where buildings/structures are dilapidated.

1.10 NOTARIAL TIE OF ERVEN

The township owner shall, at its own costs, after proclamation of the township but prior to the development of any erf/unit in the township, notarially tie the following erven to the satisfaction of the local authority:

1.10.1 Erf 9120 with Erven 8791 and 8792, Lotus Gardens Extension 31.

1.11 RESTRICTION ON THE TRANSFER OF ERVEN

Erven 9120 to 9122 shall, prior to or simultaneously with registration of the first transfer of an erf in the township and at the costs of the township owner, be transferred only to the Non Profit Company ("NPC") which organisation shall have full responsibility for functioning and proper maintenance of the said erven and the engineering services within the said erven.

- 1,12 OBLIGATIONS WITH REGARD TO ENGINEERING SERVICES AND RESTRICTION REGARDING THE TRANSFER OF ERVEN
 - 1.12.1 The township owner shall, at its own costs and to the satisfaction of the local authority, remove all refuse, building rubble and/or other materials from Erven 9120 to 9122 prior to the transfer of the erf/erven in the name of the Non Profit Company ("NPC").
 - 1.12.2 The township owner shall, at its own costs and to the satisfaction of the local authority, design, provide and construct all engineering services including the internal roads and the stormwater reticulation, within the boundaries of the township. Erven and/or units in the township, may not be transferred into the name of a purchaser, prior to the local authority certifying to the Registrar of Deeds that these engineering services had been provided and installed; and
 - 1.12.3 The township owner shall within such period as the Local Authority may determine, fulfil its obligations in respect of the provision of water, electricity and sanitary services as well as the construction of roads and stormwater drainage and the installation of systems thereof, as previously agreed upon between the township owner and the local authority. Erven may not be transferred into the name of a purchaser prior to the Local Authority certifying that sufficient guarantees / cash contributions in respect of the supply of services by the township owner have been submitted or paid to the said Local Authority; and
 - 1.12.4 Notwithstanding the provisions of clause 4 hereunder, the township owner shall, at its costs and to the satisfaction of the local authority, survey and register all servitudes required to protect the engineering services provided, constructed and/or installed as contemplated in 1.12.2 and/or 1.12.3 above. Erven and/or units in the township, may not be transferred into the name of a purchaser, prior to the Local Authority certifying to the Registrar of Deeds that these engineering services had been or will be protected to the satisfaction of the local authority.

1.13 ESTABLISHMENT OF A NON PROFIT COMPANY

The township owner shall at its own cost establish a Non Profit Company ("NPC") in terms of schedule 1 of the Companies Act, 2008 (Act 71 of 2008) as amended, with the main object of the Company being to retain and maintain the internal engineering services (i.e. water and sewer reticulation, electricity, roads and stormwater and refuse removal). The township owner shall further submit proof that such a Company has been duly registered, before a section 101, section 82 Certificate shall be issued in terms of the Town Planning and Townships Ordinance, 15 of 1986.

2. DISPOSAL OF EXISTING CONDITIONS OF TITLE

All erven shall be made subject to existing conditions and servitudes in Deed of Transfer T66072/2014, if any.

- 2.1 Excluding the following which do not affect the township due to its locality:
 - "B. 3. CONDITIONS OF TITLE

- 3.1 CONDITIONS OF TITLE IMPOSED IN FAVOUR OF THE LOCAL AUTHORITY IN TERMS OF THE PROVISIONS OF THE TOWN-PLANNING AND TOWNSHIPS ORDINANCE, 1986 (ORDINANCE 15 OF 1986)
 - 3.1.1 ALL ERVEN (EXCEPT ERVEN 9120 TO 9122)
 - 3.1.1.1 The erf shall be subject to a servitude, 2m wide, for municipal services (water, sewer, electricity and stormwater) (hereinafter referred to as "the services"), in favour of the Municipality, along any two boundaries, excepting a street boundary and, in the case of a panhandle erf, an additional servitude for municipal purposes, 3m wide, over the entrance portion of the erf, if and when required by the Municipality: Provided that the Municipality may waive any such servitude.

- 3.1.1.2 No buildings or other structures may be erected within the aforesaid servitude area and no trees with large roots may be planted within the area of such servitude or within a distance of 2m from thereof.
- 3.1.1.3 The City of Tshwane shall be entitled to temporarily deposit on the land adjoining the aforesaid servitude, any material it excavates during the laying, maintenance or removal of such services and other works which in its discretion it regards necessary, and furthermore the City of Tshwane shall be entitled to reasonable access to the said property for the aforesaid purpose, subject to the provision that the City of Tshwane shall make good any damage caused during the laying, maintenance or removal of such services and other works.

3.1.2 ERF 9120

- 3.1.2.1 The entire erf as indicated on the General Plan, is subject to a servitude for right of way in favour of the local authority and Erven 8797 to 9119 and 9121 and 9122 within the township.
- 3.1.2.2 The entire erf, as indicated on the General Plan, is subject to a servitude for municipal purposes in favour of the local authority.
- 3.1.3 ERF 8797 TO 9119 and 9121 and 9122
 - 3.1.3.1 The Erf shall be entitled to a right of way servitude over Erf 9120 as indicated on the general plan.
- 3.1.4 ERVEN 9121 AND 9122
 - 3.1.4.1 The entire erf shall be subject to a servitude in favour of the local authority for the protection of open spaces.
 - 3.1.4.2 The entire erf shall be subject to a servitude of use in favour of Erven 8797 to 9120.
- 3.1.5 ERVEN 8797 TO 9120
 - 3.1.5.1 The entire erf shall be entitled to a servitude of use over Erven 9121 and 9122.
- 3.2 CONDITIONS OF TITLE IMPOSED IN FAVOUR OF THIRD PARTIES TO BE REGISTERED/CREATED ON FIRST REGISTRATION OF THE ERVEN CONCERNED

No erf in the township may be transferred nor shall a Certificate of Registered Title be registered, unless the following conditions and/or servitudes have been registered:

3.2.1 ALL ERVEN (EXCEPT ERVEN 9120 TO 9122)

Each and every owner of the erf or owner of any subdivided portion of the erf or owner of any unit thereon, shall on transfer automatically become and remain a member of Lotus Gardens Extension 31 and 32 Home Owners Association Non Profit Company ("NPC") and shall be subject to its Memorandum of Incorporation until he/she ceases to be an owner and such owner shall not be entitled to transfer the erf or any sub-divided portion thereof or any interest therein or any unit thereon, without a clearance certificate from the NPC of certifying that the provisions of the Memorandum of Incorporation ("MOI") have been complied with.

3.2.2 ERF 9120

Lotus Gardens Extension 31 and 32 Home Owners Association Non Profit Company ("NPC") shall maintain the stormwater attenuation system on the erf, to the satisfaction of the local authority.

3.2.3 ERF 9120

The erf is subject to a servitude of right of way in favour of Erven 8797 to 9119 and 9121 to 9122 for access purposes, as indicated on the General Plan.

3.2.4 ERVEN 9120, 9121 AND 9122

The erf shall not be transferred into the name of any purchaser other than Lotus Gardens Extension 31 and 32 Home Owners Association Non Profit Company ("NPC") without the written consent of the local authority first having been obtained and the Erf shall be transferred together with any private open space Erf as the first transfers from the Township.
