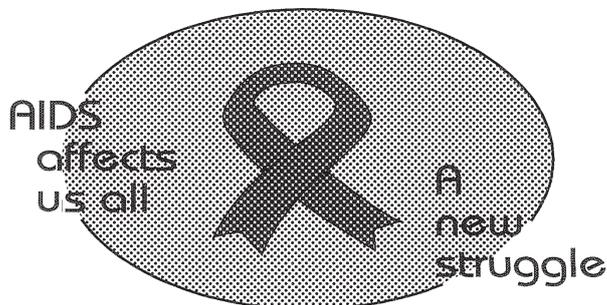

**PROCLAMATION REGARDING THE APPOINTMENT AND DESIGNATION OF MEMBERS OF GAUTENG COMMISSION ON TRADITIONAL LEADERSHIP DISPUTES AND CLAIMS**

I, Molemolla David Makhura, Premier, after consultation with the MEC responsible for Human Settlements, Urban Planning and Cooperative Governance and Traditional Affairs, in the Province of Gauteng hereby, in accordance with paragraph 11 of Part A of the Schedule to the above-mentioned Proclamation, as promulgated under General Notice 894 of 2022 published in the Provincial *Gazette*, Extraordinary No. 267 dated 8 July 2022, amend paragraph 2 of Part A of that Schedule, as indicated herein below.



**Amendment of Part A of Schedule to Proclamation Regarding the Appointment and Designation of Members of Gauteng Commission on Traditional Leadership Disputes and Claims**

1. Part A of the Schedule to the Proclamation Regarding the Appointment and Designation of Members of Gauteng Commission on Traditional Leadership Disputes and Claims (General Notice 894 of 2022 (Provincial *Gazette*, Extraordinary dated 8 July 2022)) is hereby amended by the substitution of paragraph 2 of the following paragraph:

"2. The Commission is appointed for a term of office of 12 months and must commence with its investigative work by no later than Monday, **[1 November 2021]** 2 May 2022. It must conclude the investigation and provide a final report and recommendations to me through the MEC for Human Settlements, Urban Planning and Cooperative Governance and Traditional Affairs by no later than **[Monday 31 October 2022]** Friday, 28 April 2023."
