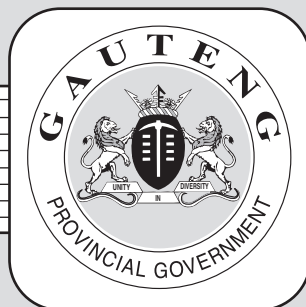

Applicable Town Planning Scheme: City of Johannesburg Land Use Scheme, 2018

Notice is hereby given, in terms of section 21 and 41 of the City of Johannesburg Municipal Planning By-Law, 2016 that I, Kamogelo Kola being the authorised agent intend to apply to the City of Johannesburg for the amendment of City of Johannesburg Land Use Scheme, 2018 and removal of restrictive conditions of the title.

Site Description: Portion 2 of Erf 3 Vandia Grove situated at 67 Elgin Road, Vandia Grove.

Application Type: To remove certain conditions and other outdated provisions and definitions contained in the title deed namely conditions (1.1), (1.2), (1.3), (1.4), (1.5), (1.6), (1.7), (1.7.1), (1.7.2), (1.7.3), (1.8), (1.9), (1.10), (1.11), (1.12), (1.13), (1.14), (1.15), (1.16), (1.17), (1.18), (1.19), (1.20) & (1.21) in Deed of Transfer No. T 56346/1986 which restrict the proposed land use and to rezone the property from Residential 1 to Residential 2 (31 dwelling units per hectare).

Application purpose: The purpose of the application is to increase the residential density on the property and remove restrictive conditions of the title.
