It is hereby notified that in terms of the provisions of section 90(5) of the Town Planning and Townships Ordinance No. 16 of 1986, read together with section 63(11) of the City of Ekurhuleni Metropolitan Municipality By-Law, 2019 that an application for the alteration/ or partial cancellation of the general plan of the township known as Tembisa Extension 6 Township has been approved. The affected properties are contained on sheets 2; 4; 5; 6; 7; 8 of the general plan L No. 648/1990. The above-mentioned General Plan has been partially cancelled by the exclusion of Erven 2352 - 2597, 2623 - 3001, 3037 – 3043 and 3051 – 3371 as represented by S.G No. L648/1990. The cancelled portion is now known as the remainder of Portion 66 of the farm Olifantsfontein No. 410-JR (S.G. No. 2395/2021).
