PROVINCIAL NOTICE 1041 OF 2022

NATIONAL LAND TRANSPORT ACT, 5 OF 2009
GAUTENG DEPARTMENT OF ROADS AND TRANSPORT
NOTICE: THE DRAFT GAUTENG PROVINCIAL LAND TRANSPORT FRAMEWORK (PLTF) IS AVAILABLE FOR PUBLIC REVIEW AND COMMENT

The Member of Executive Council (MEC) tasked with Transport and Logistics in the Gauteng Province hereby gives notice that the first draft of the Gauteng Provincial Land Transport Framework (PLTF) has been completed and is available for inspection, public review and comment at the regional offices and website stated below in terms of the Gauteng Regulations on Procedures to be Followed in Promoting Public Participation in the Transport Planning Process, 2013.

The review, development, and update of the PLTF for the Gauteng Province has been prepared in line with the requirements of the National Land Transport Act (NLTA), 5 of 2009, Section 35, the National Land Transport Strategic Framework (NLTSF), as well as sections 6 and 7 of the Regulations Relating to the Minimum Requirements for the Preparation of Provincial Land Transport Frameworks, 2011.

Section 35 of the NLTA is quoted below for ease of reference.

“Provincial Land Transport Frameworks

- (1) *Every MEC must prepare a five-year Provincial Land Transport Framework in accordance with the requirements prescribed by the Minister after consultation with all the MECs.*
- (2) *The Provincial Land Transport Framework must provide a transport framework as an overall guide to transport planning within the province, being guided by the National Land Transport Strategic Framework.*
- (3) *Provincial Land Transport Frameworks must include the planning of both intraprovincial and interprovincial long-distance services, which must be linked where applicable with other public transport services, and in the case of interprovincial transport, this must be done in consultation with the MEC of the other province or provinces concerned.*
- (4) *The Minister must, as soon as possible after the commencement of this Act, in consultation with the MECs and by notice in the Gazette, determine a date by which each province must have prepared its Provincial Land Transport Framework.*
- (5) *All Provincial Land Transport Frameworks must include routes for the transporting of dangerous goods through the province, as reflected in the integrated transport plans within its jurisdiction.*
- (6) *The date for preparing integrated transport plans must be linked to the Provincial Land Transport Frameworks and must be agreed upon by the MECs and planning authorities.*
- (7) *The Provincial Land Transport Framework must summarise all available integrated transport plans in the province.*
- (8) *The last Provincial Land Transport Framework prepared under the Transition Act is regarded for all purposes as the Provincial Land Transport Framework prepared in terms of this Act, until the new Provincial Land Transport Framework has been approved by the MEC.*
- (9) *The MEC must update the Provincial Land Transport Framework every two years.*
- (10) *The Provincial Land Transport Framework must be submitted to the Minister for approval on or before the date determined under subsection (4) and must be accompanied by copies of all agreements regarding interprovincial transport concluded between province and other provinces.*

(11) *The Minister's approval in terms of subsection (10) is limited to –*

- a. monitoring compliance with the National Land Transport Strategic Framework and with this Act and other applicable legislation;*
- b. procedures and financial issues that affect the national government;*
- c. seeing that the MEC followed the correct procedures and otherwise complied with the prescribed requirements;*
- d. national policies and principles regarding interprovincial and cross-border transport; and*
- e. modes and aspects of transport under the control of the national government or national public entities.”*

Sections 6 and 7 of the Regulations Relating to the Minimum Requirements for the Preparation of Provincial Land Transport Frameworks are quoted below for ease of reference:

“Invitation to the public

6 (1) In terms of section 35 of the Act, the MEC must prepare a five-year PLTF in accordance with the requirements prescribed by the Minister after consultation with other MECs.

(2) Once the first draft of the PLTF has been completed, the MEC must publish a notice in the Provincial Gazette and in at least two newspapers circulating in the Province notifying the public of the completion and availability for inspection of the first draft PLTF.

(3) The notice must invite the public to inspect the draft PLTF at the offices of the Department of Roads and Transport throughout the Province and also for download from the website of the Department.

(4) The notice must include a date not less than 30 days from the date of publication, by which the public may submit written comments and inputs on the PLTF to the Department for consideration.”

“Meeting with Planning Authorities and other Government Departments

7 (1) The MEC must invite Planning Authorities and other relevant Government Departments to discuss comments and inputs as received from the public as contemplated in regulation 6 of these regulations.

(2) Depending on the comments and inputs received from other Government Departments and Planning Authorities, the first draft PLTF may be revised and a second draft produced for further consultation.

(3) All reasonable steps should be taken by the Department to ensure that the PLTF as a transport planning tool finds expression in the development of the Integrated Development Plans as contemplated in section 23 of the Municipal Systems Act, 200 (Act No. 32 of 2000).”

The updated PLTF will provide a framework and overall guide to transport planning in Gauteng for a five-year period spanning 2022 to 2026.

The objectives of the Gauteng PLTF are as follows:

- To give broad strategic direction to the development of transport in the Gauteng Province;
- To give an overview of the status quo of transport in the province from a provincial perspective;
- To indicate land use development trends and the desirable spatial development of the province, and what transport measures and actions should be put in place to support the intended spatial development;
- To give an overview of development initiatives of provincial significance in the province, including budgets and implementation programmes; to report on the monitoring of transport in the province and identified trends;
- To indicate and summarise actions taken in the province to coordinate and integrate transport planning and management initiatives by municipalities and other organs of state in the province responsible for transport matters; and
- To indicate how the MEC has implemented the functions and responsibilities assigned to the province by the NLTA.

The draft Gauteng PLTF builds on existing literature resources and reflects inputs received from stakeholders and key role-players during the past six months. The 30-day public inspection period of the draft Gauteng PLTF starts on **Friday, 18 November, and ends on Friday, 13 January 2023**. The public may submit written comments and inputs to the Department for consideration by not later than 13 January 2023.
