

It is hereby notified in terms of the provisions of Sections 48(2) and 50(5) of the City of Ekurhuleni Metropolitan Municipality Spatial Planning and Land Use Management By-law, 2019, that the City of Ekurhuleni Metropolitan Municipality has approved the removal of restrictive title condition 1 from Deed of Transfer T22239/2017 and hereby adopted the land development application for the amendment of the City of Ekurhuleni Land Use Scheme, 2021 by the rezoning of Erf 30302 Daveyton Township from "Residential 2" to "Business 2" for a Liquor Distribution only.

The approved Amendment Scheme documents will lie for inspection at the Manager: Town Planning, Benoni Sub Section, Cnr Tom Jones and Elston Avenue 6th Floor; Treasury Building, Benoni during normal office hours.

This amendment is known as City of Ekurhuleni Amendment Scheme B0652 and shall come into operation on the date of publication of this notice.
