Under the powers vested in me by section 16(3)(c) of the Local Government: Municipal Structures Act, 1998 (Act No. 117 of 1998), I, Mzikayifani Khumalo, Member of the Executive Council responsible for local government in the Province of Gauteng, hereby, after consultation with the Rand West City Local Municipality, the Merafong City Local Municipality and organised local government in the Province of Gauteng, publish particulars of the proposed Notice that further amend the Notice establishing the abovementioned municipalities (Notice No. 4862 of 2005) as set out in the Schedule hereto for public comment.

The proposed amendment Notice makes provision for the Municipal Councils of the abovementioned municipalities to designate the duly elected executive deputy mayors as full time councillors.

## **SCHEDULE**

Notice No. 4862 of 2005, published in the Gauteng Provincial Gazette Extraordinary No. 527 dated 6 December 2005, as amended, is hereby further amended by amending the Schedule thereto as follows:

### **AMENDMENT OF PART 4**

1. *Amendment of clause 24*

Clause 24 is hereby amended by the addition of the following clause:

“(24A) The council of the Rand West City Local Municipality may designate the deputy executive mayor as a full-time councillor.”

### **AMENDMENT OF PART 10**

2. *Amendment of clause 59*

Clause 59 is hereby amended by the addition of the following clause:

“(59A) The council of the Merafong City Local Municipality may designate the deputy executive mayor as a full-time councillor.”
