**SCHEDULE**

In terms of section 18(3) of the Local Government: Municipal Structures Act, 1998 (Act 117 of 1998) the MEC for local government has determined that the municipal council consists of 10 councillors. After having consulted the Independent Electoral Commission, The Municipal Demarcation Board has delimited the municipality into 5 wards in terms of Schedule 1 of the Act.

The number of registered voters in each ward does not vary by more than fifteen percent from the norm. The norm was determined by dividing the total number of voters on the municipal segment of the national common voters roll, namely 15985 voters on 31 March 2000, by the number of wards in the municipality.

Map No. 1 indicating the outer boundary of Ward 1, consists of 3580 voters and comprises the following:

- Portion of Voting District 43450017 consisting of 2680 registered voters
- Portion of Voting District 43413690 consisting of 900 registered voters

Map No. 2 indicating the outer boundary of Ward 2, consists of 2995 voters and comprises the following:

- Portion of Voting District 43413690 consisting of 1410 registered voters
- Portion of Voting District 43450028 consisting of 1585 registered voters

Map No. 3 indicating the outer boundary of Ward 3, consists of 3072 voters and comprises the following:

- Portion of Voting District 43413735 consisting of 612 registered voters
- Portion of Voting District 43413836 consisting of 1540 registered voters
- Portion of Voting District 43413847 consisting of 585 registered voters
- Portion of Voting District 43413858 consisting of 335 registered voters

Map No. 4 indicating the outer boundary of Ward 4, consists of 3184 voters and comprises the following:

- Portion of Voting District 43414736 consisting of 325 registered voters
- Portion of Voting District 43413623 consisting of 1068 registered voters
- Portion of Voting District 43413825 consisting of 1381 registered voters
- Portion of Voting District 43490011 consisting of 410 registered voters

Ingevolge artikel 18(3) van die Wet op Plaaslike Regering: Munisipale Strukture, 1998 (Wet 117 van 1998) het die LUR vir plaaslike regering bepaal dat die munisipale raad bestaan uit 10 raadslede. Na oorlegpleging met die Onafhanklike Verkiesingskommissie het die Municipale Afbakeningsraad die munisipaliteit in 5 wyke afgebaken ingevolge Bylae 1 van die Wet.
