## MISCELLANEOUS/DIVERSE

### NON APPROVAL OF A LAND DEVELOPMENT AREA

I, Stephen Graham Simpson in my capacity as Designated Officer of the uMngeni Municipality appointed in terms of Section 1 of the Development Facility Act (No. 67 of 1995) and as required in terms of Section 33 of the Act, hereby advise of the non-approval of a land development area in terms of the proposed establishment of a retirement village, game estate and equestrian center situate on Portions 118, Rem of 116 and 133 (of 116) all of the Farm Stocklands and Oatlands No. 878 and Rem of the Farm Oatlands No. 16124, Howick.

The Tribunal having heard all the evidence before it in the documentation at the hearing and to the additional information provided by the applicant after the conclusion of the hearing, the Tribunal came to the unanimous conclusion that the deficiencies, varied application proposals and the premature assumption that the development will comply with the Spatial Development Framework and Integrated Development Plan for the area outweigh the merits of extending the retirement village, combined with a game lodge development and equestrian center. The application was consequently rejected.

### REASONS FOR THE JUDGEMENT

- The varied nature of the proposals is in conflict with sound town planning and spatial development planning principles.
- The rights of those occupying land intended for agricultural purposes within the development are threatened and cannot be adequately protected.
- The rights of purchasers of units in a retirement village to peaceful and tranquil occupation are equally threatened and cannot be pro-

tected if agricultural and commercial activities continue on properties adjoining and within proposed areas for retirement units.

- In the absence of any provision of staff accommodation within the development, the question of transport of employees involved in the proposed development during and after the construction phase has not been adequately addressed.
- The question of adequacy of a single access point for all three components of the proposed development is questionable.
- The traffic hazard which would result from increased traffic accessing the narrow Provincial Road and the lack of any pedestrian walkway or side walk, to serve employees having to walk into Howick.
- The density involved in the proposed development in comparison with density in the neighbouring development has not been appropriately responded to.
- The need for an equestrian activity within the development site has not been adequately motivated and is deemed to be inappropriate to the requirements of a retirement village.
- The development site falls outside the Howick Spatial Development Framework and Integrated Development Plan and it is premature to anticipate the effect any updated plan will have on it.
