

## MUNICIPAL DEMARCATION BOARD NOTICE IN TERMS OF SECTION 21 OF THE LOCAL GOVERNMENT: MUNICIPAL DEMARCATION ACT, 1998 (KwaZulu-Natal)

"In terms of section 21 of the Local Government: Municipal Demarcation Act, 1998 (Act No. 27 of 1998), read with Sections 2 and 4 of the Local Government: Municipal Structures Act, 1998 the Municipal Demarcation Board has re-determined the municipal boundaries of Umgungundluvu District Municipality by including the Msunduzi Local Municipality into the municipal area of Umgungundlovu.

The implication of this notice, if confirmed in terms of section 21(5) of the Demarcation Act, 1998, is that The Msunduzi's current status as a local municipality (Category B) within the municipal area of Umgungundluvu District Municipality will continue after the 2011 local government elections.

Further reconfigurations of municipal boundaries, will be considered after the 2011 local elections.
