

**KWAZULU-NATAL  
UMSEKELI MUNICIPAL SUPPORT SERVICES ORDINANCE  
REPEAL BILL, 2010**

**BILL**

**To provide for the repeal of the uMsekeli Municipal Support Services Ordinance, 1941; and to provide for matters connected therewith.**

BE IT ENACTED by the Provincial Legislature of the Province of KwaZulu-Natal, as follows:-

**Definitions**

1. In this Act, unless the context indicates otherwise –

"**Department**" means the department in the Provincial Government of KwaZulu-Natal responsible for local government;

"**Gazette**" means the official *Provincial Gazette* of KwaZulu-Natal;

"**Head of Department**" means the most senior officer of the department in the Provincial Government of KwaZulu-Natal responsible for local government;

"**Provincial Treasury**" means the Treasury established for KwaZulu-Natal under section 17 of the Public Finance Management Act, 1999 (Act No. 1 of 1999);

"**regulations**" means regulations made in terms of section 4;

"**responsible Member of the Executive Council**" means the Member of the Executive Council responsible for local government in the Province;

"**this Act**" includes the Schedule;

"**uMsekeli**" means the corporate body established in terms of section 2 of the uMsekeli Municipal Support Services Ordinance, 1941 (Ordinance No. 20 of 1941).

**Repeal of laws**

2. The laws mentioned in the Schedule are hereby repealed to the extent set out in the third column of the said Schedule.

**Disestablishment of uMsekeli and transitional provisions incidental thereto**

3.(1) uMsekeli, including –

- (a) the Board referred to in section 2(1); and
- (b) the Management Body referred to in section 2(2)(a),

of the repealed uMsekeli Municipal Support Services Ordinance, 1941 (Ordinance No. 20 of 1941), are hereby disestablished.

(2) On the date of the commencement of this Act, all assets, liabilities, rights, duties and obligations, including any unspent portion of any funds accrued or received under the repealed uMsekeli Municipal Support Services Ordinance, 1941, of the disestablished uMsekeli, including the Board and the Management Body referred to in subsection (1), are transferred to, and vest in, the Department.

(3) The Department is, in respect of the assets, liabilities, rights, duties and obligations and funds referred to in subsection (2), for all purposes the successor-in-law of the disestablished uMsekeli, including the Board and the Management Body referred to in subsection (1).

(4) The responsible Member of the Executive Council must, subject to applicable labour law, deal with the employees of the disestablished uMsekeli who were appointed in terms of section 31(3) of the repealed uMsekeli Municipal Support Services Ordinance, 1941.

**Responsible Member of Executive Council may make regulations**

4. The responsible Member of the Executive Council may, if in the application of this Act administrative problems are being experienced, by notice in the *Gazette*, make regulations to remove such administrative problems.

**Validation**

5. Any act, determination, designation, decision, matter or any other thing done, made, taken, executed or carried out or purported to have been done, made, taken, executed or carried out by the Management Body of the disestablished uMsekeli appointed in terms of section 2(2) of the repealed uMsekeli Municipal Support Services Ordinance, 1941 (Ordinance No. 20 of 1941), in terms of or in pursuance of the repealed uMsekeli Municipal Support Services Ordinance, 1941, from 1 January 2000 to the date of commencement of this Act, is not invalid by reason only of the names of the persons appointed to the Management Body in terms of section 2(2)(b) of the repealed uMsekeli Municipal Support Services Ordinance, 1941, not having been published in

the *Gazette* as required by section 2(2)(c) of that Ordinance.

**Short title**

6. This Act is called the KwaZulu-Natal uMsekeli Municipal Support Services Ordinance Repeal Act, 2010.

## **MEMORANDUM ON THE OBJECTS OF THE UMSEKELI MUNICIPAL SUPPORT SERVICE ORDINANCE REPEAL BILL, 2010**

### **GENERAL**

uMsekeli Municipal Support Services ("uMsekeli"), previously referred to as the Development and Services Board, falls within the ambit of the Abolition of Development Bodies Act, 1986, which included "*the Development and Services Board mentioned in section 1 of the Development and Services Board Ordinance, 1941 (Ordinance No. 20 of 1941), of Natal*".

Section 2(2) of the said Act provided that the Minister of Constitutional Development and Planning may by notice in the Gazette abolish any Development and Services Board with effect from a date mentioned in such notice, although no such notice was published for KwaZulu-Natal.

Subsequently, the Local Government Transition Act, 1993 (Act 209 of 1993), was enacted, providing for revised interim measures to promote the restructuring of local government, and empowering the Member of the Executive Council responsible for local government in the Province to promulgate transitional measures, to ensure a smooth transition to the restructured entities.

In line with the abovementioned Act, uMsekeli continued to function as a Municipality in numerous areas in KwaZulu-Natal such as Bulwer and Port Shepstone, and as uMsekeli was to assist with the establishment of Municipalities, the Development and Services Board Ordinance, 1941 (Ordinance No. 20 of 1941) ("the Ordinance"), was amended *vide* Proclamation No. 26 of 2000, to enable uMsekeli to function as a support service to municipalities in KwaZulu-Natal, post 2000.

However, as the full suite of local government legislation has now been enacted, and although uMsekeli is still performing local government functions for numerous municipalities, it can no longer exist in harmony with the new order legislation. Sections 83 and 84 of the Local Government: Municipal Structures Act, 1998 (Act No. 117 of 1998), specify the functions that district or local municipalities are to perform, whilst section 76 of the Local Government: Municipal Systems Act, 2000 (Act 32 of 2000), allows a municipality to provide a municipal service through an external mechanism, by entering into a service delivery agreement with a variety of entities.

Whilst uMsekeli may qualify as such an external mechanism, it can no longer exist as a "*local authority*" as contemplated in the Ordinance, and for this reason the Executive Council resolved on 29 March 2006 that uMsekeli is to be disestablished. In compliance with this resolution, the uMsekeli Municipal Support Service Ordinance Repeal Bill, 2006, was submitted to the Speaker of the Provincial Legislature, who subsequently referred the Bill to the Local Government Portfolio Committee for deliberation and a recommendation.

However, as a result of the inability of the Department to accurately establish the financial implications of the disestablishment of uMsekeli, the Bill lapsed on the date of the subsequent provincial elections, hence the revival of the repeal Bill by virtue of this Bill.

**NOTES ON CLAUSES****Clause 1: Definitions**

In clause 1, an endeavour has been made to include an exhaustive list of words and expressions, which need to be specifically defined for the purposes of the Bill.

**Clause 2: Repeal of laws**

Clause 2 provides that laws contemplated in the Schedule are repealed to the extent indicated in the third Column of the Schedule.

**Clause 3: Disestablishment of uMsekeli and transitional provisions incidental thereto**

Clause 3 provides that uMsekeli, including the Board and the Management Body are disestablished, with all the assets, liabilities, rights, duties and obligations, including any unspent portion of any funds accrued or received by uMsekeli, being transferred to, and vesting in, the Department as successor-in-law to uMsekeli, and that the responsible Member of the Executive Council must deal with the employees of the disestablished uMsekeli in accordance with the applicable labour laws.

**Clause 4: Responsible Member of Executive Council may make regulations**

Clause 4 provides that the responsible Member of the Executive Council may make regulations to remove any administrative problems experienced in the application of the Act.

**Clause 5: Validation**

Clause 4 provides that any act performed by the Management Body in terms of the repealed Ordinance between 1 January 2000 and the date of commencement of this Act, is not invalid by reason only of the fact that the names of the persons appointed to the Management Body were not published in the Gazette.

**Clause 6: Short title**

This is a standard clause.

**Schedule: Repeal of laws**

As contemplated in clause 2, the Schedule contains all the laws that are to be repealed by this Act.

**BODIES AND ORGANISATIONS CONSULTED**

The Board and Management Body of uMsekeli.

**FINANCIAL IMPLICATIONS FOR THE PROVINCE**

There are no longer any financial implications for the disestablishment of uMsekeli.

**IMPLICATIONS FOR MUNICIPALITIES**

No direct implications.

**LEGISLATIVE PROCEDURE**

The Bill was originally certified by the Provincial Chief State Law Advisor on 4 April 2006, and has now been recertified for introduction in the Provincial Legislature now that the financial implications have been fully dealt with and resolved.

## WETSONTWERP

**Om voorsiening te maak vir die herroeping van die Ordonnansie op die uMsekeli Munisipale Ondersteuningsdienste, 1941; en om vir aangeleenthede wat daarmee verband hou, voorsiening te maak.**

DAAR WORD soos volg deur die Provinciale Wetgewer van die provinsie KwaZulu-Natal bepaal:-

### Omskrywings

1. In hierdie Wet, tensy uit die konteks anders blyk, beteken –

"Departement" die departement in die Provinciale Regering van KwaZulu-Natal verantwoordelik vir plaaslike regering;

"Departementshoof" die mees senior amptenaar van die departement in die Provinciale Regering van KwaZulu-Natal verantwoordelik vir plaaslike regering;

"hierdie Wet" ook die bylae;

"Koerant" die amptelike *Provinciale Koerant* van KwaZulu-Natal;

"Provinciale Tesourie" die Tesourie ingestel vir KwaZulu-Natal ingevolge artikel 17 van die Wet op Openbare Finansiële Bestuur, 1999 (Wet No. 1 van 1999);

"regulasies" die regulasies uitgevaardig ingevolge artikel 4;

"uMsekeli" die regspersoon ingestel ingevolge artikel 2 van die Ordonnansie op die uMsekeli Munisipale Ondersteuningsdienste, 1941 (Ordonnansie No. 20 van 1941); en

"verantwoordelike Lid van die Uitvoerende Raad" die Lid van die Uitvoerende Raad verantwoordelik vir plaaslike regering in die provinsie.

### Herroeping van wette

2. Die wette vermeld in die bylae word hierby herroep tot die mate wat in die derde kolom van die genoemde bylae aangetoon is.

**Ontbinding van uMsekeli en oorgangsbeplings wat daarmee verband hou**

3.(1) uMsekeli, met inbegrip van –

- (a) die Raad vermeld in artikel 2(1); en
- (b) die Bestuursliggaam vermeld in artikel 2(2)(a),

van die herroepe Ordonnansie op die uMsekeli Munisipale Ondersteuningsdienste, 1941 (Ordonnansie No. 20 van 1941), word hierby ontbind.

(2) Op die datum van die inwerkingtreding van hierdie Wet word alle bates, laste, regte, pligte en verpligtinge, met inbegrip van enige onbestede gedeelte van fondse toegeval of ontvang ingevolge die herroepe Ordonnansie op die uMsekeli Munisipale Ondersteuningsdienste, 1941, van die ontbinde uMsekeli, met inbegrip van die Raad en Bestuursliggaam vermeld in subartikel (1), aan die Departement oorgedra en gaan dit oor op hom.

(3) Die Departement is, ten opsigte van bates, laste, regte, pligte en verpligtinge en fondse vermeld in subartikel (2), vir alle doeleindes dieregsopvolger van die ontbinde uMsekeli, met inbegrip van die Raad en die Bestuursliggaam vermeld in subartikel (1).

(4) Die verantwoordelike Lid van die Uitvoerende Raad moet, behoudens toepaslike arbeidswetgewing, met die werknemers van die ontbinde uMsekeli handel wat ingevolge artikel 31(3) van die herroepe Ordonnansie op die Ordonnansie op die uMsekeli Munisipale Ondersteuningsdienste, 1941 aangestel is.

**Verantwoordelike Lid van Uitvoerende Raad kan regulasies uitvaardig**

4. Die verantwoordelike Lid van die Uitvoerende Raad kan, indien administratiewe probleme ondervind word by die toepassing van hierdie Wet, by kennisgewing in die *Koerant* regulasies uitvaardig om sodanige administratiewe probleme die hoof te bied.

**Bekragtiging**

5. Enige handeling, bepaling, aanwysing, besluit, aangeleentheid of enige ander ding gedoen, gemaak, geneem of uitgevoer of onderneem of voorgegee om gedoen, gemaak, geneem, uitgevoer of onderneem te wees deur die Bestuursliggaam van die ontbinde uMsekeli, aangestel ingevolge artikel 2(2) van die herroepe Ordonnansie op die uMsekeli Munisipale Ondersteuningsdienste, 1941 (Ordonnansie No. 20 van 1941), ingevolge of ooreenkomsdig die herroepe Ordonnansie op die uMsekeli Munisipale Ondersteuningsdienste, 1941 vanaf 1

Januarie 2000 tot die datum van inwerkingtreding van hierdie Wet, is nie ongeldig slegs op grond van die feit dat die name van die persone in die Bestuursraad aangestel ingevolge artikel 2(2)(b) van die herroepe Ordonnansie op die uMsekeli Municipale Ondersteuningsdienste, 1941 nie in die *Koerant* gepubliseer is soos deur artikel 2(2)(c) van daardie Ordonnansie vereis word nie.

**Kort titel**

## **MEMORANDUM OOR DIE OOGMERKE VAN DIE HERROEPINGSWETSONTWERP OP DIE ORDONNANSIE OP DIE UMSEKELI MUNISIPALE ONDERSTEUNINGSDIENSTE, 2010**

### **ALGEMEEN**

uMsekeli Municipale Ondersteuningsdienste (“uMsekeli”), voorheen bekend as die Raad op Ontwikkeling en Dienste, val binne die trefwydte van die Wet op Afskaffing van Ontwikkelingsliggame, 1986, wat “die Raad op Ontwikkeling en Dienste vermeld in artikel 1 van die Ordonnansie op die Raad op Ontwikkeling en Dienste, 1941 (Ordonnansie No. 20 van 1941) van Natal” insluit.

Artikel 2(2) van die gemelde Wet bepaal dat die Minister van Staatkundige Ontwikkeling en Beplanning by wyse van ‘n kennisgewing in die Staatskoerant enige Raad op Ontwikkeling en Dienste kon afskaf met ingang van ‘n datum vermeld in sodanige kennisgewing, hoewel geen sodanige kennisgewing vir KwaZulu-Natal gepubliseer is nie.

Daarna is die Oorgangswet op Plaaslike Regering, 1993 (Wet No. 209 van 1993) gepromulgeer wat vir hersiene tussentydse maatreëls voorsiening maak om die hersamestelling van plaaslike regering te bevorder, en die lid van die Uitvoerende Raad verantwoordelik vir plaaslike regering in die provinsie magtig om tussentydse maatreëls te promulgeer ten einde ‘n gladde oorgang na die hersaamgestelde entiteite te verseker.

In ooreenstemming met die bogenoemde Wet het uMsekeli voortgegaan om as munisipaliteit in verskeie gebiede soos Bulwer en Port Shepstone te funksioneer, en aangesien uMsekeli bystand moes verleen met die instelling van munisipaliteite is die Ordonnansie op die Raad op Ontwikkeling en Dienste, 1941 (Ordonnansie No. 20 van 1941) (“die Ordonnansie”) gewysig deur Proklamasie No. 26 van 2000 ten einde uMsekeli in staat te stel om na 2000 as ‘n ondersteuningsdiens vir munisipaliteite te funksioneer.

Aangesien ‘n volledige stel plaaslike regeringswetgewing nou gepromulgeer is, kan uMsekeli nie langer in harmonie met die wetgewing van die nuwe bedeling bestaan nie, alhoewel uMsekeli steeds plaaslike regeringsfunksies vir verskeie munisipaliteite verrig. Artikels 83 en 84 van die Wet op Plaaslike Regering: Municipale Strukture, 1998 (Wet No. 117 van 1998) spesifiseer die funksies wat distrikts- of plaaslike munisipaliteite moet verrig, terwyl artikel 76 van die Wet op Plaaslike Regering: Municipale Stelsels, 2000 (Wet No. 32 van 2000) ‘n munisipaliteit in staat stel om ‘n municipale diens deur ‘n eksterne meganisme te lewer deur ‘n diensleweringsooreenkoms met ‘n verskeidenheid entiteite aan te gaan.

Hoewel uMsekeli as sodanige eksterne meganisme kwalifiseer, kan dit nie langer voortbestaan as 'n "plaaslike regering" soos bedoel in die Ordonnansie nie, en om hierdie rede het die Uitvoerende Raad op 29 Maart 2006 besluit om uMsekeli te ontbind. Ter nakoming van hierdie besluit, is die Herroepingswetsontwerp op die Ordonnansie op die uMsekeli Municipale Ondersteuningsdienste, 2006 aan die speaker van die Provinciale Wetgewer voorgelê, wat daarna die Wetsontwerp na die Portefeuiljekomitee vir Plaaslike Regering verwys het vir oorweging en 'n aanbeveling.

As gevolg van die onvermoë van die Departement om die finansiële implikasies van die ontbinding van uMsekeli akkuraat vas te stel, het die Wetsontwerp egter op die datum van die daaropvolgende provinsiale verkiesing verstryk, vandaar die herstel van die Herroepingswetsontwerp uit hoofde van hierdie Wetsontwerp.

## **AANTEKENINGE OOR KLOUSULES**

### **Klousule 1: Omskrywings**

In klousule 1 is gepoog om 'n uitputlike lys van woorde en uitdrukings in te sluit wat spesifiek vir die doel van hierdie Wetsontwerp omskryf moet word.

Klousule 3 bepaal dat uMsekeli, met inbegrip van die Raad en die Bestuursliggaam, ontbind word en dat alle bates, laste, regte, pligte en verpligtinge, insluitend enige onbestede gedeelte van fondse wat uMsekeli toegeval het of deur hom ontvang is, aan die Departement oorgedra word en op hom oorgaan asregsopvolger van uMsekeli, en dat die verantwoordelike Lid van die Uitvoerende Raad met die werknemers van die ontbinde uMsekeli handel in ooreenstemming met die toepaslike arbeidswette.

### **Klousule 4: Verantwoordelike Lid van Uitvoerende Raad kan regulasies uitvaardig**

Klousule 4 bepaal dat die verantwoordelike Lid van die Uitvoerende Raad regulasies kan uitvaardig om administratiewe probleme wat met die toepassing van hierdie Wet ervaar word, die hoof te bied.

**Klousule 5: Bekragtiging**

Klousule 5 bepaal dat enige handeling wat deur die Bestuursliggaam ingevolge die herroepse Ordonnansie tussen 1 Januarie 2000 en die datum van inwerkingtreding van hierdie Wet verrig is, nie ongeldig is nie slegs op grond van die feit dat die name van die persone in die Bestuursraad aangestel nie in die *Koerant* gepubliseer is nie.

**Klousule 6: Kort titel**

Dit is 'n standaardklousule.

**Bylae: Herroeping van wette**

Soos in klousule 2 vermeld, bevat die bylae al die wette wat deur hierdie Wet herroep word.

Emva kwalokho kwamiswa uMthetho wesiKhashana woHulumeni baseKhaya, 1993 (uMthetho No. 209 ka 1993), owawuhlinzekela izinguquko zesikhashana ezibuyekeziwe zokugquqquzelwa ukuhlelwa kabusha kohulumeni basekhaya, kanye nokuniqa iLungu loMkhandlu oPhethe elibhekelle ohulumeni basekhaya esifundazweni amandla okumemezelwa izinguquko zesikhashana, nokuqinisekisa ukudlulisewa kahle kwezinguquko ezinhalkeni ezintsha.

**BILL**

**To repeal certain laws pertaining to local government in the Province of KwaZulu-Natal that became obsolete as a result of laws enacted since 1994; and to provide for related matters.**

BE IT ENACTED by the Legislature of the Province of KwaZulu-Natal, as follows:-

**Repeal of laws**

**1.** The laws mentioned in Parts A, B, C, D and E of the Schedule are hereby repealed to the extent indicated in the third column of the said Schedule.

**Short title**

**2.** This Act is called the KwaZulu-Natal Local Government Laws Repeal Act, 2010.

**MEMORANDUM ON THE OBJECTS OF THE KWAZULU-NATAL LOCAL GOVERNMENT LAWS REPEAL BILL, 2010**

**1. BACKGROUND**

A fundamental change in the structure of local government introduced by the Constitution of the Republic of South Africa, 1996, which included the notion of co-operative governance and the creation of local government as a sphere of government in its own right with significant executive and legislative powers, created an awkward relationship between the post-1994, "new-order" legislation and the pre-1994, "old-order" provincial ordinances.

A host of new-order legislation has been passed since 1994 and a rationalisation of local government laws-exercise was conducted with a view to remove the confusion that has arisen with regard to the application of old-order legislation within the new local government dispensation. This exercise culminated in the drafting of this Bill which repeals all redundant provisions of old-order legislation, thereby clearing the statute book of all obsolete provisions.

**2. OBJECT OF THE BILL**

The Bill seeks to repeal all provisions of the old-order legislation applicable in the province, as contemplated in Parts A, B, C, D and E of the Schedule to the Act, to the extent indicated in the third column of the Schedule, that have become obsolete as a result of local government laws that have been enacted since 1994.

**3. CONSTITUTIONAL IMPLICATIONS**

The Bill will bring local government legislation in line with the present constitutional dispensation, giving effect to the aims and objects of the Constitution as they apply to local government in KwaZulu-Natal.

**4. BODIES AND ORGANISATIONS CONSULTED**

All Municipalities within KwaZulu-Natal, as well as Organised Local Government, were consulted on the Bill during 2005, in compliance with the provisions of section 154(2) of the Constitution of the Republic of South Africa, 1996.

**5. FINANCIAL IMPLICATIONS**

**7. LEGISLATIVE PROCEDURE**

The Bill was originally certified by the Provincial Chief State Law Advisor on 14 January 2005, and has now been re-certified for introduction in the Provincial Legislature.

### **1. AGTERGROND**

'n Fundamentele verandering in die struktuur van plaaslike regering deur die Grondwet van die Republiek van Suid-Afrika teweeggebring, wat die idee van koöperatiewe regering en die daarstelling van plaaslike regering as 'n regeringsvlak in eie reg met betekenisvolle uitvoerende en wetgewende magte ingesluit het, het 'n ongemaklike verhouding tussen wetgewing ná 1994, wetgewing van die "nuwe bedeling" en die eertydse provinsiale ordonnansies, wetgewing van die "ou bedeling" geskep.
