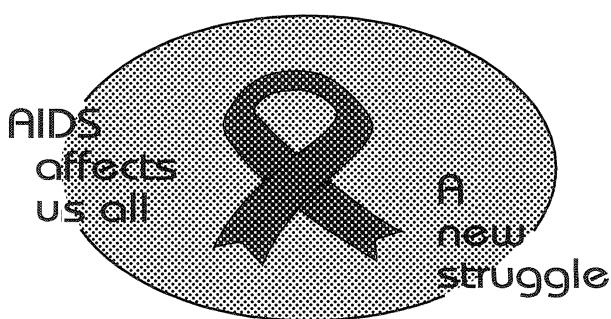

KWAZULU-NATAL GAMING AND BETTING ACT, 2010 (ACT NO. 8 OF 2010)**

SCHEDULE**Definitions**

1. In these regulations “the regulations” mean the KwaZulu-Natal Gaming and Betting Regulations, 2012, published in Provincial Notice No. 64 of 29 June 2012.

Amendment of Regulation 71

2. Regulation 71 of the regulations is hereby amended by the substitution for subregulation (5) of the following subregulation:
- “(5) The recorded data from the soft and hard count rooms must be retained for a minimum of [30] seven days.”

Amendment of Regulation 72

3. Regulation 72 of the regulations is hereby amended by the substitution for subregulation (2) of the following subregulation:
- “(2) All recordings in terms of this regulation must be retained by the licensee for at least [thirty] seven days after the recorded event.”

Amendment of Regulation 73

4. Regulation 73 of the regulations is hereby amended by the substitution for subregulation (2) of the following subregulation:
- “(2) All recordings in terms of this regulation must be retained by the licensee for at least [thirty] seven days after the recorded event.”

Amendment of Regulation 74

5. Regulation 74 of the regulations is hereby amended by the substitution for subregulation (4) of the following subregulation:

“(4) All recordings in terms of this regulation must be retained by the licensee for at least [thirty] seven days after the recorded event.”

Short title

6. These regulations are called the KwaZulu-Natal Gaming and Betting Amendment Regulations, 2013.
