

CLOSING TIMES FOR THE ACCEPTANCE OF NOTICES

1. (1) The *KwaZulu-Natal Provincial Gazette* is published every week on Thursday, and the closing time for the acceptance of notices which have to appear in the *KwaZulu-Natal Provincial Gazette* on any particular Thursday, is **15:00 one week prior to the publication date**. Should any Thursday coincide with a public holiday, the publication date remains unchanged. However, the closing date for acceptance of advertisements moves backwards accordingly, in order to allow for 5 working days prior to the publication date.
- (2) The date for the publication of an **Extraordinary** *KwaZulu-Natal Province Provincial Gazette* is negotiable.
2. (1) Notices received **after closing time** will be held over for publication in the next *KwaZulu-Natal Provincial Gazette*.
- (2) Amendments or changes in notices cannot be undertaken unless instructions are received **before 10:00 on Fridays**.
- (3) Notices for publication or amendments of original copy can not be accepted over the telephone and must be brought about by letter, by fax or by hand. The Government Printer will not be liable for any amendments done erroneously.
- (4) In the case of cancellations a refund of the cost of a notice will be considered only if the instruction to cancel has been received on or before the stipulated closing time as indicated in paragraph 2(2).

APPROVAL OF NOTICES (This only applies to Private Companies)

3. To give effect to the implementation of the Dannhauser Municipality's Rates Policy and to provide for matters incidental thereto.

Preamble

WHEREAS section 6(1) of the local government: Municipal Property Rates Act, 2004(no.6 of 2004) as amended, requires a municipality to adopt By-laws to give effect to the implementation of its Rates Policy;

AND WHEREAS section 6(2) of the local government: Municipal Property Rates Act,2004(no.6 of 2004) as amended ,provides that Bylaws adopted in terms of section 6(1) may differentiate between different categories of properties, and different categories of owners of properties liable for the payment of rates.

BE IT THEREFORE ENACTED by the council of the Dannhauser municipality as follows:

1. Definitions

In this Bylaw any word or expression to which a meaning has been assigned in the local Government: Municipal Property Rates act, 2004(Act 6 of 2004) shall bear the same meaning and unless the context indicates otherwise-

“Act” means the Local Government: Municipal Property Rates Act

“Council” means the Council of Dannhauser Municipality; and

“Rate” or “Rates” means a municipal rate on property as envisaged in section 229 of the Constitution of the Republic of South Africa.

2. Adoption and implementation of Rates Policy

- (1) The council shall adopt and implement rates policy consistent with Act on the levying of rates on rateable property within the jurisdiction of the municipality; and

- (2) The Council shall not be entitled to levy rates other than terms of its Rates Policy.

3. Contents of Rates Policy

The council Rates Policy shall inter alia:

- (1) Apply to all rates levied by the council pursuant to the adoption of its annual budget;
- (2) Comply with the requirements for:
 - The adoption of contents of a rates policy specified in section 3 of the Act
 - The Process of community participation specified in section 4 of the act; and
 - The annual review of rates policy specified in section 5 of the Act.
- (3) Specify any further principles, criteria and implementation measures consistent with the act for the levying of Rates which council may adopt; and
- (4) Include such further enforcement mechanisms, if any as the council may wish to impose

4. Enforcement of Rates Policy

The council's Rates Policy shall be enforced through the Credit Control and Debt Collection By-law and Policy and any further enforcement mechanisms stipulated in the Act and Council's Rates Policy

5. Short title and commencement

This is the Rates By-law, and takes effect on 1 July 2013
