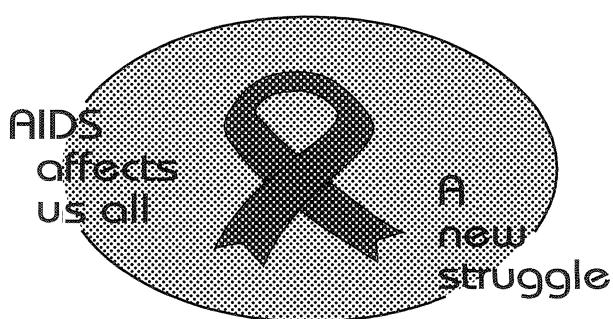

READ WITH THE PROVISIONS OF SECTION 35 OF THE LOCAL GOVERNMENT: MUNICIPAL STRUCTURES ACT,
1998: APPOINTMENT OF AN ADMINISTRATOR OF THE MPOFANA MUNICIPALITY AND THE DETERMINATION OF
THE POWERS AND FUNCTIONS OF THE ADMINISTRATOR**

I, Nomusa Dube-Ncube, in my capacity as Member of the KwaZulu-Natal Executive Council responsible for local government, and in terms of section 139(1)(c) of the Constitution of the Republic of South Africa 1996 (Act 108 of 1996), hereby –

- (a) under powers vested in me by section 35(1) of the Local Government: Municipal Structures Act, 1998 (Act No. 117 of 1998), appoint Ms Buhle Ally as the Administrator of the Mpofana Municipality (hereinafter referred to as “the Municipality”), with effect from 3 September 2014; and
- (b) in accordance with the provisions of section 35(2) of the Local Government: Municipal Structures Act, 1998, determine that the Administrator must exercise and perform the following powers and functions:
 - (i) undertake all executive functions of the Municipal Council, but excluding the legislative functions;
 - (ii) represent the Municipality on the Council of the uMgungundlovu District Municipality;
 - (iii) undertake all statutory executive functions of the Mayor;
 - (iv) undertake the functions referred to in section 67(1)(h) and Schedule 2 of the Local Government: Municipal Systems Act, 2000 (Act No. 32 of 2000), read with any other relevant legislative provisions dealing with criminal, disciplinary and civil matters;
 - (v) ratify all decisions taken by the Municipal Manager and managers directly accountable to the Municipal Manager in terms of delegated or original authority;
 - (vi) devise a turnaround strategy for the Municipality;
 - (vii) implement a system for the control and approval of all expenditure;
 - (viii) ensure the implementation of financial systems, policies and procedures;
 - (ix) ensure the implementation of the Local Government: Municipal Property Rates Act, 2004 (Act No. 6 of 2004);
 - (x) devise a specific strategy to address the financial challenges of the Municipality, including a strategy to reduce unnecessary expenditure and to increase the collection of revenue;
 - (xi) prepare the adjustment budget for the 2014/2015 financial year; and
 - (xii) review the organisational structure of the Municipality.

Ek, Nomusa Dube-Ncube, in my hoedanigheid as Lid van die KwaZulu-Natal Uitvoerende Raad verantwoordelik vir plaaslike regering, en ingevolge artikel 139(1)(c) van die Grondwet van die Republiek van Suid-Afrika, 1996 (Wet 108 van 1996), hiermee –

- (a) kragtens die bevoegdheid aan my verleen deur artikel 35(1) van die Wet op Plaaslike Regering: Munisipale Strukture, 1998 (Wet No. 117 van 1998), Me. Buhle Ally aanstel as die Administrateur van die Mpofana Munisipaliteit (hierna verwys na as "die Munisipaliteit"), met inwerkingtreding vanaf 3 September 2014; en
- (b) in ooreenstemming met die bepalings van artikel 35(2) of the Wet op Plaaslike Regering: Munisipale Strukture, 1998, bepaal dat die Administrateur die volgende bevoegdhede moet uitoefen en funksies verrig:
 - (i) alle uitvoerende funksies van die Munisipale Raad onderneem, maar die wetgewende funksies uitgesluit;
 - (ii) die Munisipaliteit verteenwoordig op die Raad van die uMgungundlovu Distriksmunisipaliteit;
 - (iii) alle statutêre uitvoerende funksies van die Burgemeester onderneem;
 - (iv) die funksies verwys na in artikel 67(1)(h) en Bylae 2 van die Wet op Plaaslike Regering: Munisipale Strukture, 2000 (Wet No. 32 van 2000), gelees met enige ander tersaaklike wetgewende bepalings wat handel oor strafregtelike, dissiplinêre en siviele aangeleenthede, onderneem;
 - (v) alle besluite geneem deur die Munisipale Bestuurder en bestuurders, wat regstreeks aanspreeklik is aan die Munisipale Bestuurder ingevolge gedelegeerde of oorspronklike gesag, goedkeur;
 - (vi) 'n omkeerstrategie vir die Munisipaliteit ontwerp;
 - (vii) 'n stelsel vir die beheer en goedkeuring van alle besteding implementeer;
 - (viii) verseker dat die implementering van finansiële stelsels, beleide en prosedures uitgevoer word;
 - (ix) verseker dat die implementering van die Wet op Plaaslike Regering: Munisipale Eiendomsbelasting, 2004 (Wet No. 6 van 2007), uitgevoer word;
 - (x) 'n spesifieke strategie ontwerp vir die aanspreek van die Munisipaliteit se finansiële uitdagings, ingesluit 'n strategie vir die verlaging van onnodige besteding en om die invordering van belasting te verhoog;
 - (xi) die aansuiweringsbegroting vir die 2014/2015 finansiële jaar voorberei; en
 - (xii) die organisatoriese struktuur van die Munisipaliteit hersien.
