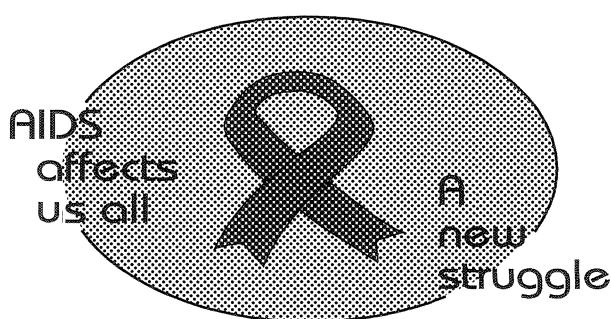

**MUNICIPAL NOTICE—MUNISIPALE KENNISGEWING—ISAZISO SIKAMASIPALA****No. 140****24 October 2014****DEPARTMENT OF CO-OPERATIVE GOVERNANCE AND TRADITIONAL AFFAIRS****NOTICE IN TERMS OF SECTION 16(3)(c) OF THE LOCAL GOVERNMENT: MUNICIPAL STRUCTURES ACT, 1998 – PROPOSED NAME CHANGE OF THE MFOLOZI MUNICIPALITY**

1. The Member of the KwaZulu-Natal Executive Council responsible for local government, under the powers vested in her by section 16(1) of the Local Government Municipal Structures Act, 1998 (Act No. 117 of 1998), proposes to publish the following notice, amending Provincial Notice No. 239, published in the KwaZulu-Natal Provincial Gazette No. 201 dated 4 December 2008 (as amended), in order to give effect to a decision by the Municipal Council of the Mfolozi Municipality to alter the name of the local municipality from the Mfolozi Municipality to the uMfolozi Municipality:

*"I, Nomusa Dube-Ncube, in my capacity as Member of the KwaZulu-Natal Executive Council responsible for local government, under the powers vested in me by section 16(1)(b) of the Local Government: Municipal Structures Act, 1998 (Act No. 117 of 1998), hereby amend Provincial Notice No. 239, published in the KwaZulu-Natal Provincial Gazette No. 201 dated 4 December 2008 (as amended), by the deletion of the reference to "Mfolozi Municipality" wherever it may appear in the Notice, and by the replacement thereof by a reference to "uMfolozi Municipality"."*

1. ILungu loMkhandlu oPhethe KwaZulu-Natali elibhekele ezohulumeni basekhaya, ngokwamandla eliwanikezwe isigaba 16(1) soMthetho weziNhlaka zoMasipala woHulumeni baseKhaya, 1998 (uMthetho No. 117 ka 1998), lihlongoza ukushicilela isaziso esilandelayo, esichibiyela iSaziso sesiFundazwe No. 239 esashicilelw *kwiGazethi yesiFundazwe No. 201 mhla zi-4 kuZibandlela 2008 (njengoba sichtishiyelwe)*, ukuze kuqaliswe isinqumo soMkhandlu kaMasipala waseMfolozi sokuthi kushintshwe igama likamasipala wasekhaya elithi uMasipala wesiKhaya saseMfolozi kuthi esikhundleni salo kufakwe igama elithi uMasipala waseuMfolozi:

1. Die Lid van die KwaZulu-Natal Uitvoerende Raad verantwoordelik vir plaaslike regering, kragtens die bevoeghede aan haar verleen deur artikel 16(1) van die Wet op Plaaslike Regering: Munisipale Strukture, 1998 (Wet No. 117 van 1998), is van voorneme om die volgende kennisgewing te publiseer, en Proviniale Kennisgewing No. 239, gepubliseer in die KwaZulu-Natal Proviniale Koerant No. 201, gedateer 4 Desember 2008 (soos gewysig), te wysig ten einde uitwerking te gee aan 'n besluit deur die Municipale Raad van die Mfolozi Municipaliteit om die naam van die plaaslike municipaliteit te wysig vanaf die Mfolozi municipaliteit na die uMfolozi Municipaliteit:
