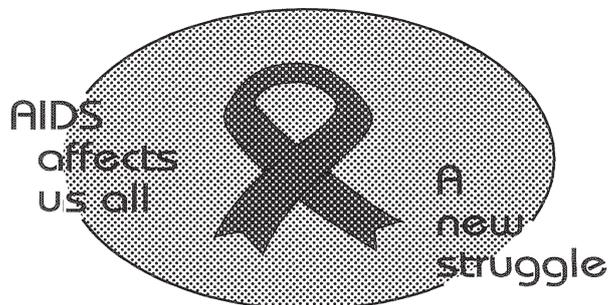

PROVINCIAL NOTICE 156 OF 2016

DEPARTMENT OF COOPERATIVE GOVERNANCE AND TRADITIONAL AFFAIRS

EXTENSION OF THE DECLARATION OF A KWAZULU-NATAL PROVINCIAL STATE OF DISASTER

I, TW Mchunu, in my capacity as Premier of the Province of KwaZulu-Natal, under powers vested in me by section 41(5)(c) of the Disaster Management Act, 2002 (Act No. 57 of 2002), hereby, as a result of the continuing protracted drought and the subsequent damage and possibility of loss of life, extend the declaration of a state of disaster in –

(a) the eThekweni Metropolitan Municipality; and

(b) the Local Municipalities contemplated in Column 2 of the Schedule, falling within the area of jurisdiction of the District Municipalities contemplated in Column 1 of the Schedule,

for a period of one month from 11 September 2016 to 10 October 2016.
