

**NOTICE 90 OF 2016****DEPARTMENT OF COOPERATIVE GOVERNANCE AND TRADITIONAL AFFAIRS****NOTICE IN TERMS OF SECTION 16(3)(c) OF THE LOCAL GOVERNMENT: MUNICIPAL STRUCTURES ACT, 1998 (ACT NO. 117 OF 1998): KING CETSHWAYO MUNICIPALITY**

1. The Member of the KwaZulu-Natal Provincial Executive Council, responsible for Cooperative Governance and Traditional Affairs, in her capacity as the Member of the Executive Council responsible for local government, and under the powers vested in her by section 16(1)(d) of the Local Government Municipal Structures Act, 1998 (Act No. 117 of 1998), to amend notices issued in terms of section 12 of the said Act, and in order to give effect to a decision by the Municipal Council of the King Cetshwayo Municipality to designate 6 additional Executive Committee Members, the Whip and Chairperson of Municipal Public Accounts Committee as full-time Councillors, proposes to publish the following notice:

*"I, Nomusa Dube-Ncube, Member of the KwaZulu-Natal Executive Council responsible for local government, under powers vested in me by section 16(1)(d), read with section 18(4), of the Local Government: Municipal Structures Act, 1998 (Act No. 117 of 1998), hereby determine that the King Cetshwayo Municipality, in addition to the Speaker, the Mayor and the Deputy Mayor, may designate 6 additional Executive Committee Members, as well as the Whip and the Chairperson of the Municipal Public Accounts Committee, as full-time Councillors."*
