

NOTICE IN TERMS OF SECTION 16(3)(c) OF THE LOCAL GOVERNMENT: MUNICIPAL STRUCTURES ACT, 1998 (ACT NO. 117 OF 1998): INKOSI LANGALIBALELE MUNICIPALITY

1. The Member of the KwaZulu-Natal Provincial Executive Council, responsible for Cooperative Governance and Traditional Affairs, in her capacity as the Member of the Executive Council responsible for local government, and under the powers vested in her by section 16(1)(d) of the Local Government Municipal Structures Act, 1998 (Act No. 117 of 1998), to amend notices issued in terms of section 12 of the said Act, and in order to give effect to a decision by the Municipal Council of the Inkosi Langalibalele Municipality to designate the Whip and Chairperson of the Municipal Public Accounts Committee as full-time Councillors, proposes to publish the following notice:

"I, Nomusa Dube-Ncube, Member of the KwaZulu-Natal Executive Council responsible for local government, under powers vested in me by section 16(1)(d), read with section 18(4), of the Local Government: Municipal Structures Act, 1998 (Act No. 117 of 1998), hereby determine that the Inkosi Langalibalele Municipality, in addition to the Speaker, the Mayor and the Deputy Mayor, may designate the Whip and Chairperson of the Municipal Public Accounts Committee, as full-time Councillors."

2. The public and interested parties are invited to submit comments in writing on the proposed amendment by no later than seven days after the date of publication hereof, by–
