

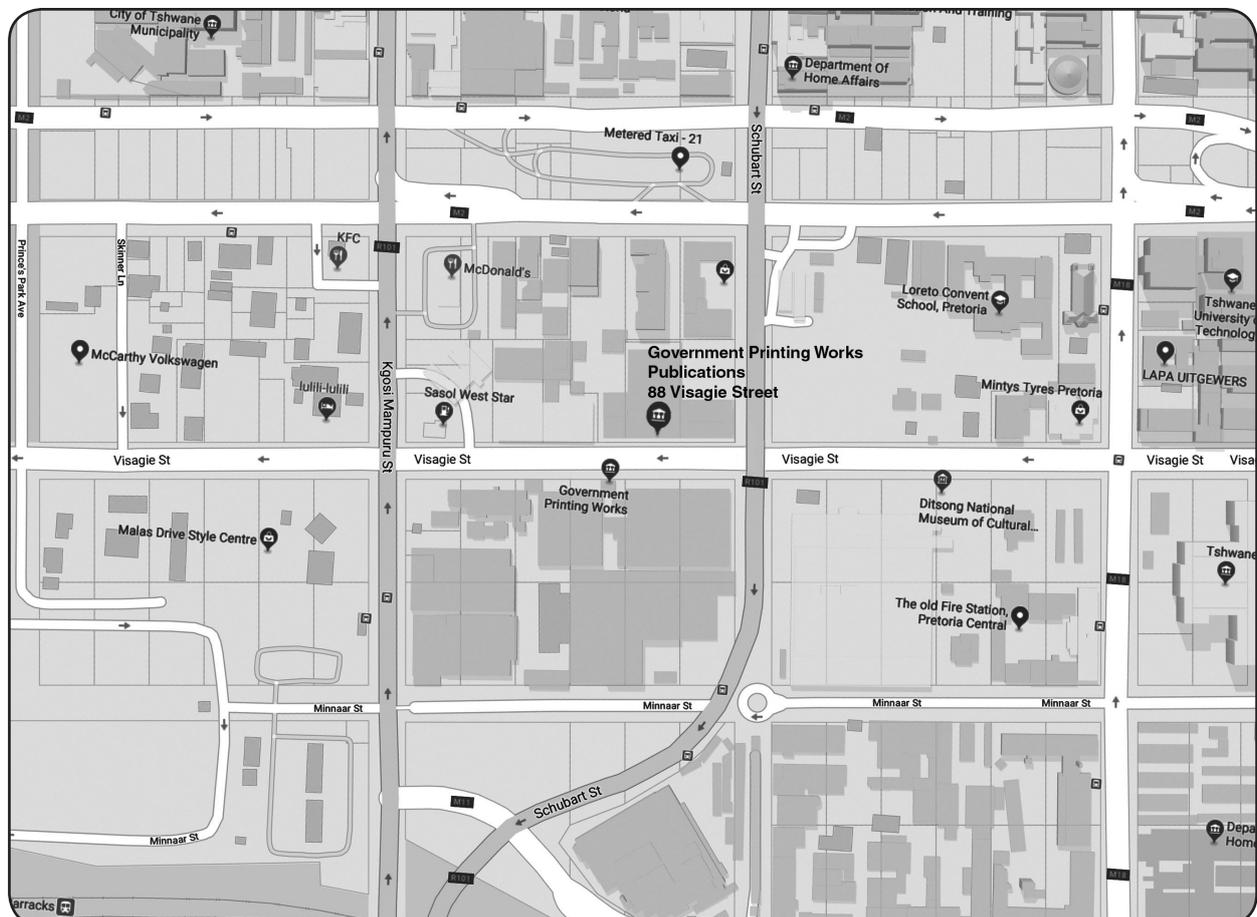

NOTICE 51 OF 2019**DEPARTMENT OF COOPERATIVE GOVERNANCE AND TRADITIONAL AFFAIRS****NOTICE IN TERMS OF SECTION 16(3)(c) OF THE LOCAL GOVERNMENT: MUNICIPAL STRUCTURES ACT, 1998 (ACT NO. 117 OF 1998): ALFRED DUMA MUNICIPALITY**

1. The Member of the KwaZulu-Natal Provincial Executive Council, responsible for Cooperative Governance and Traditional Affairs, in his capacity as the Member of the Executive Council responsible for local government, and under the powers vested in him by section 16(1)(d) of the Local Government Municipal Structures Act, 1998 (Act No. 117 of 1998), to amend notices issued in terms of section 12 of the said Act, and in order to give effect to a decision by the Municipal Council of the Alfred Duma Municipality to designate the Chairperson of the Women's Caucus Committee as full-time Councillor, proposes to publish the following notice:

"I, Siphon Emmanuel Hlomuka, Member of the KwaZulu-Natal Executive Council responsible for local government, under powers vested in me by section 16(1)(d), read with section 18(4), of the Local Government: Municipal Structures Act, 1998 (Act No. 117 of 1998), hereby determine that the Alfred Duma Municipality, in addition to the Speaker, Mayor, Deputy-Mayor, Whip and the Chairperson of the Municipal Public Accounts Committee, may designate the Chairperson of the Women's Caucus Committee as full-time Councillor."
