

Call for nominations of suitably qualified individuals to fill Board vacancies in Richards Bay Industrial Development Zone (RBIDZ)

The MEC of Economic Development, Tourism and Environmental Affairs, the Honourable, Ms. Nomusa Dube-Ncube invites interested parties to submit nominations for the appointment of suitable individuals to the Board of Directors of the entity. RBIDZ is a company which is wholly owned by the Provincial Government of KwaZulu-Natal. It is a public entity listed in Schedule 3D of the Public Finance Management Act, 1999 (Act No. 1 of 1999). The RBIDZ is a licensed operator of the Richards Bay Industrial Development Zone. Its purpose is to develop and operate the Richards Bay Industrial Development Zone in order attract investment to the Richards Bay area, create employment and promote the beneficiation of local resources (including metals, minerals and agricultural products), primarily for the export market.

Retiring directors may also be nominated for re-appointment. The appointments shall be for a period of 3 years.

The following persons shall be eligible for appointment to the Board

- Nominees must not be disqualified from being a director of a company and at least 4 nominees must meet
 the requirements of independence allowing for appointment to the Audit Committee of a company, as
 contemplated in section 94 of the Companies Act, 2008. Nominees may be subject to vetting.
- Nominees should meet the requirements for independence contemplated in the King III and King IV reports on Corporate Governance and should possess qualifications, skills, experience and knowledge in one or more of the following areas:
 - Economics, law, finance, corporate governance, HR, accounting, commerce, industry, public
 affairs, business management, industrial development, property development, industrial
 beneficiation and value addition processes, the export and import sectors, trade and customs
 control, investment promotion, ports and any other skill, experience or qualification that might be
 of benefit to the RBIDZ.
- The nominator must submit a brief CV of the nominated candidate, the nominator's motivation for appointment of the nominee and a letter of acceptance of the nomination by the nominee.

Call for nominations of suitably qualified individuals to serve on the Board of Directors of Ithala Development Finance Corporation Limited

The MEC of Economic Development, Tourism and Environmental Affairs, the Honourable, Ms. N Dube-Ncube invites interested parties to submit nominations for the appointment to the Board of Directors, as required in terms of Section 6 of the Kwazulu-Natal Development Finance Corporation 2013 (Act No.0 5 of 2013. Ithala Development Finance Corporation Limited is a Schedule 3D Public Entity in terms of the Public Finance Management Act, 1999 (Act No: 1 of 1999).

The following persons shall NOT be eligible for appointment to the Board:

- a member of parliament, any provincial legislature or any municipal council;
- is or becomes an un-rehabilitated insolvent;
- is or has been declared of unsound mind by a competent court of law;
- is directly or indirectly involved in any contract with Ithala and fails to declare such involvement in such a
 contract and the nature thereof in the manner required by a governing statute; a person under
 curatorship:
- has, at any time, been removed from an office of trust on account of misconduct involving theft or fraud;
- has been convicted and sentenced to a term of imprisonment without the option of a fine, except that
 the responsible Member of the Executive Council, may, upon receipt of an affidavit disclosing full details
 of an offence by a person nominated for appointment, condone a conviction in a manner that is
 consistent with section 106(1) (e) of the Constitution: provided that a disqualification in terms of this subsection ends five (5) years after the sentence has been completed.
- Individuals who have nominated themselves.

The MEC will consider and appoint individual/s who collectively possesses:

- Extensive financial management, credit management and corporate governance skills;
- Extensive knowledge of and experience of in Information Technology.
- Legal qualification and experience particularly in Litigation, Property Law and / or Environmental Law or qualification and experience in Information, Communication & Technology

Nominations should be in writing and accompanied by:

- a Curriculum Vitae (CV) of the candidate; certified copies of qualifications and ID;
- any supporting information and contact details of at least two (2) references; and
- a signed nomination and acceptance letter of the nomination from the candidate.

All the nominees must be based in the province of KwaZulu-Natal. Preference will be given to achieving the equitable spatial representation of municipalities, especially women, in terms of Section 6 of KwaZulu-Natal Ithala Development Finance Corporation (Act No: 5 of 2013).
