

I, Nomusa Dube-Ncube, in my capacity as Member of the KwaZulu-Natal Executive Council for Economic Development, Tourism and Environmental Affairs, and in terms of section 33(1) of the National Environmental Management: Protected Areas Act, 2003 (Act No. 57 of 2003) hereby –

(1) give notice of my intention to declare the properties described in the Schedule hereunder, as a Protected Environment as contemplated in terms of section 28(1) of the National Environmental Management: Protected Areas Act, 2003, to be named the Central Umngeni Conservancy Protected Environment; and

(2) invite members of the public to submit written representations on, or objections to, the proposed declaration of the above-mentioned Central Umngeni Conservancy Protected Environment, as well as any comments on the draft Management Plan of the Central Umngeni Conservancy Protected Environment, within 60 days of the publication of this notice: Provided that –

(a) the Draft Management Plan may be viewed at the Offices of Ezemvelo KZN Wildlife at Queen Elizabeth Park, Pietermaritzburg, 3201, or on <http://www.kznwildlife.com/stewardship.html>; and

(b) written submissions must be lodged:
