DECLARATION OF THE ROELTON NATURE RESERVE IN TERMS OF SECTION 23(1) OF THE NATIONAL ENVIRONMENTAL MANAGEMENT: PROTECTED AREAS ACT, 2003

- I, Nomusa Dube-Ncube, in my capacity as Member of the KwaZulu-Natal Provincial Executive Council for Economic Development, Tourism and Environmental Affairs, hereby declare and make known that -
 - (a) subsequent to the publication of Notice Number 2056 of 14 March 2019, in Provincial *Gazette* Number 2056, in which my intention to declare the Roelton Nature Reserve was duly published in accordance with the requirements of section 33(1) of the National Environmental Management: Protected Areas Act, 2003 (Act No. 57 of 2003);
 - (b) in accordance with powers vested in me by section 23(1) of the National Environmental Management Act, 2003, the properties and parts thereof
 - (i) described in the Schedule and the Surveyor-General Diagrams attached to the Schedule as Annexure A and
 - (ii) with effect from the date of publication hereof,
 - is a Nature Reserve as contemplated in section 23(1)(a)(i) of the National Environmental Management: Protected Areas Act, 2003; and
 - (c) the said Nature Reserve will be known as the Roelton Nature Reserve, as contemplated in section 23(1)(b) of the National Environmental Management: Protected Areas Act, 2003.


Category of protected area (section 23(1)(i) of the National Environmental Management: Protected Areas Act (No. 57 of 2003): **Nature Reserve**.

Description of the properties or parts thereof comprising the Roelton Nature Reserve:

The extent of the nature reserve is shown in a separate surveyed SG Diagram (SG no. 200/2019) annexed hereto (Annexure 'A'), with the parts of the properties proposed to be declared measuring in extent 113,5920 hectares, framed for the purposes of declaring a Nature Reserve over and relating to the following properties or parts thereof:

- (a) The Remaining Extent of the Farm Roelton Number 4222, Registration Division ET, Province of KwaZulu Natal, in extent 200,2108 (Two hundred comma two one zero eight) hectares, a ¾ share being held by Deed of Transfer No T10134/1997, and a ¼ share being held by Deed of Transfer No T6223/2009; and
- (b) The Remaining Extent of the Farm Watershed Number 5779, Registration Division ES, Province of KwaZulu Natal, in extent 314,1961 (Three hundred and fourteen comma one nine six one) hectares, a ¾ share being held by Deed of Transfer No T10134/1997, and a ¼ share being held by Deed of Transfer No T6223/2009.
