REPUBLIC OF SOUTH AFRICACALL FOR NOMINATION OF INDIVIDUALS TO SERVE ON THE KWAZULU-NATAL NATURE  
CONSERVATION BOARD (EZEMVELO KZN WILDLIFE)

By virtue of the powers vested in me as the Member of the KwaZulu-Natal Provincial Executive Council responsible for environmental affairs and in terms of section 4(4)(a) of the KwaZulu-Natal Nature Conservation Management Act, 1997 (Act No. 9 of 1997), I hereby invite interested parties within the Province to nominate candidates for appointment to the KwaZulu-Nature Conservation Board for a period of **three years**.

The KwaZulu-Natal Nature Conservation Board, generally referred to as Ezemvelo KZN Wildlife, is a provincial public entity, listed in Part C of Schedule 3 to the Public Finance Management Act, 1999 (Act No. 1 of 1999), reporting to the KwaZulu-Natal Department of Economic Development, Tourism and Environmental Affairs. The entity is mandated to direct the management of nature conservation within the Province, including protected areas, as well as the development and promotion of ecotourism facilities within the protected areas.

To qualify for nomination, the candidate may not be disqualified from being a Director of a company, must meet the requirements for appointment as contemplated in section 94 of the Companies Act, 2008 (Act No. 71 of 2008) and must meet the requirements for independence contemplated in the King IV Report on Corporate Governance.

In order to be considered for appointment, the candidate must have demonstrable Corporate Governance experience, as well as appropriate knowledge, experience and qualifications in one or more of the following sectors:

- (a) business and finance;
- (b) environmental law;
- (c) labour matters; and
- (d) the protection and management of heritage resources.

The following parties/ bodies are encouraged to nominate appropriate candidates:

- (a) the KwaZulu-Natal Provincial House of Traditional Leaders;
- (b) non-governmental organisations, institutions or groups established for the advancement of nature conservation or environmental protection within the province;
- (c) community-based organisations in rural areas in the province;
- (d) the KwaZulu-Natal Tourism Authority; and
- (e) organised agriculture;

**A nominator, providing substantive motivation, must nominate the proposed candidate in writing, which nomination the proposed candidate must accept in writing, in addition to which the proposed candidate must submit:**

- (a) a detailed Curriculum Vitae or CV;**
- (b) certified copies of qualifications and his / her Identity Document; and**
- (c) supporting information and contact details of at least two References,**

**failing which, the nominee will be disqualified and not be considered for appointment.**

All nominations must be marked "**Nomination to the Ezemvelo Board**" and be addressed in writing to the Head of Department, 270 Jabu Ndlovu Street, Pietermaritzburg, 3201 or to Private Bag X9152, Pietermaritzburg, 3200, alternatively sent via email to [Board.applications@kznedtea.gov.za](mailto:Board.applications@kznedtea.gov.za) under the same heading.
