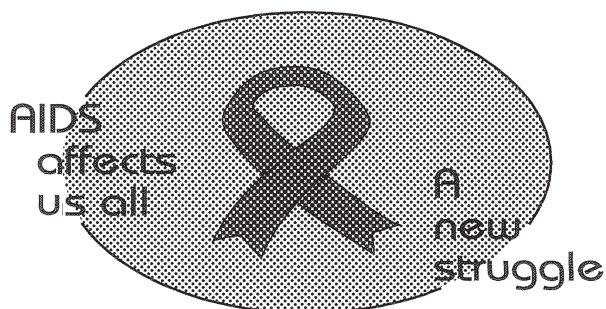

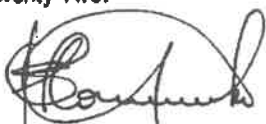

**NOTICE IN TERMS OF SECTION 16(1)(d) OF THE LOCAL GOVERNMENT: MUNICIPAL STRUCTURES ACT, 1998: DETERMINATION OF FULL-TIME COUNCILLORS – UGU DISTRICT MUNICIPALITY**
