

DEPARTMENT OF COOPERATIVE GOVERNANCE AND TRADITIONAL AFFAIRS

NOTICE IN TERMS OF SECTION 16(3)(c) OF THE LOCAL GOVERNMENT: MUNICIPAL STRUCTURES ACT, 1998 (ACT NO. 117 OF 1998): UGU DISTRICT MUNICIPALITY

- 1. The Member of the KwaZulu-Natal Executive Council responsible for Cooperative Governance and Traditional Affairs, in his capacity as the Member of the Executive Council responsible for Cooperative Governance and Traditional Affairs, under the powers vested in him by section 16(1)(d) of the Local Government Municipal Structures Act, 1998 (Act No. 117 of 1998), to amend notices issued in terms of section 12 of the said Act, and in order to give effect to a decision by the Municipal Council of the Ugu Municipality to designate the Chairperson of Municipal Public Accounts Committee and the Whip of Council as full-time Councillors, proposes to publish the following notice:
 - "I, Sihle Zikalala, the KwaZulu-Natal Member of the Executive Council responsible for Cooperative Governance and Traditional Affairs, under powers vested in me by section 16(1)(d) read with section 18(4) of the Local Government: Municipal Structures Act, 1998 (Act No. 117 of 1998), hereby determine that the Ugu Municipality may, in addition to the Speaker, Mayor, Deputy Mayor and other five Executive Committee members, designate the Chairperson of the Municipal Public Accounts Committee and the Whip of Council as full-time Councillors."
- **2.** The public and interested parties are invited to submit comments in writing on the proposed amendment by no later than seven days after the date of publication hereof, by—
