The Board reserves the right to, when making the final awards, issue conditions with the aim of protecting and pursuing the interests of the shareholders or any persons who come from the historically disadvantaged communities in compliance with the Board's objects as enunciated in section 6 (1) (c); (d); (e) and (f) of the KZN Gaming and Betting Act (Act No. 8 of 2010), as amended, which would result in the right being revoked should an awardee fail to comply with such conditions.

Once the KwaZulu-Natal Gaming and Betting Board has made the final awards, each awardee will be required to make an application for a bookmaker licence in terms of section 94 of the KZN Gaming and Betting Act 8 of 2010, as amended, within twelve (12) months in respect of the districts and defined locations referred to above, which will be subject to publication notices for public inspection as prescribed by the KwaZulu-Natal Gaming and Betting Act (Act No. 8 of 2010, as amended).

All bidders not reflected in this notice who submitted bids in relation to this RFA should consider their bids as unsuccessful since the Board only had issued a limited number of rights through this RFA.

Interested persons are hereby invited to lodge representations, if any, in respect of the awards/awardees by no later than **16:00 on Friday: 30 December 2022**. Representations should be in writing and must contain at least the following information:

- (a) The name of the person/entity to whom the representation relates,
- (b) The ground(s) on which representations are made, and
- (c) The name, address and telephone number of the person submitting the representations.
