NOTICE IN TERMS OF SECTION 16(3)(c) OF THE LOCAL GOVERNMENT: MUNICIPAL STRUCTURES ACT, 1998 (ACT NO. 117 OF 1998): MTUBATUBA LOCAL MUNICIPALITY

1. The Member of the KwaZulu-Natal Executive Council responsible for Cooperative Governance and Traditional Affairs, under the powers vested in him by section 16(1)(b) of the Local Government Municipal Structures Act, 1998 (Act No. 117 of 1998), to amend notices issued in terms of section 12 of the said Act, and in order to give effect to a decision by the Municipal Council of the Mtubatuba Local Municipality to change the name of the municipality, proposes to publish the following notice:

"I, Sihle Zikalala, Member of the KwaZulu-Natal Executive Council responsible for Cooperative Governance and Traditional Affairs, under powers vested in me by section 16(1)(b) of the Local Government: Municipal Structures Act, 1998 (Act No. 117 of 1998), hereby amend Provincial Notice No. 113, published in the KwaZulu-Natal Provincial Gazette No. 2328 dated 14 October 2021, by the deletion of the reference to "Mtubatuba Local Municipality" wherever it may appear in the Notice, and by the replacement thereof by a reference to "Inkosi uMtubatuba Local Municipality"."
