By virtue of the powers, vested in me in terms of Section 10 (3) (g) of the Local Government Transition Act, 1993 (Act 209 of 1993), as amended, I, Ratshilumela John Dombo, hereby give notice that I demarcate the area of jurisdiction of the Pietersburg/Polokwane Transitional Local Council into wards by the Schedule hereto.

Wards are demarcated, and numbered from No. 1 up to and including No. 14, as indicated on the hereby attached maps, marked—

- (a) **Map A:** Locality map of Pietersburg/Polokwane on which Pietersburg and Seshego Towns are indicated;
- (b) **Map B:** Demarcation map of Seshego on which wards Nos. 1 up to and including No. 7, are indicated;
- (c) **Map C:** Demarcation map of Pietersburg on which wards Nos. 8 up to and including No. 14, are indicated.
